- II. Action Item: 2021-2022 Election Results Challenges, Review & Recommendations
 - A. Introduction: The Questions before the Election Subcommittee & the Joint Meeting of the Election Committee and NPPC Officers are:
 - 1. Is there substance to any of the challenges that require resolution?
 - 2. Do the challengers make the case for a new election?

Those decisions are to be made by the joint committees. If any challenge(s) require resolution, they will be forwarded to the 2019-2021 Board for Action prior to the seating of the 2021-2022 Board.

- B. <u>Possible</u> Actions:
 - 1. <u>ACTION 1</u>: Accept Election Committee Report and either:
 - a) Forward to the 2019-2021 Board, or
 - b) Modify Election Committee Report and forward to the 2019-2021 NPPC Board.
 - 2. <u>ACTION 2a</u>: Accept the Challengers request and recommend the NPPC Board call a new election, or
 - 3. <u>ACTION 2b</u>: Reject the Challengers request and, recommend remedy(s) *for any substantiated challenges* to the 2019-2021 NPPC Board.
- C. Review of challenges and findings (presented by Election Subcommittee). After each category is presented, it will be opened for public comment/questions. After public comment, the Board Officers may ask questions, discuss, and take action on potential resolutions, where found to be necessary.
 - 1. No complaint specified (Challenges 1, 8, 9, 13, 14)
 - 2. Unspecified bylaws violations (2, 4, 6, 16, 17)

- e) Write-in candidates (10*, 12*, 15*, 19, 20)
- f) Run-off ballots missing (10*, 12*, 15*)
- g) Eligibility roster (10*, 12*, 15*, 20)
- h) Transparency
 - (1) No public Election Subcommittee meetings (11, 18, 19, 20)
 - (2) *Not* sharing the vote count in meeting (19)

4. Paper ballot handling

- a) Question of anonymity/secrecy (3, 10*, 11, 12*, 15*, 18, 19, 20)
- b) Pick-up and drop-off handling (3, 10*, 12*, 15*)
- c) Counting teams and process (3, 10*, 12*, 15*, 19)
- d) Soiled ballot (3)
- e) Not numbered (10*, 12*, 15*, 20)
- f) Length of vote counting (18)
- g) Lack of complete rules (18)

5. Digital ballot handling

- b) Voting software selection (11, 20)
- c) Sender of ballots was not NPPC directly (20)
- d) Lack of confirmation message for ballots received (20)
- e) Assertion that qualified voters did not receive ballots (20)

- b) Registering voters outside of NPPC meetings (5)
- c) Lack of representation of community/diversity (11, 19)
