Del Cerro/Grantville pertaining to homeless. Patrols to be increased on Del Cerro Blvd. (per Officer Steffen). Charity tickets from city for upcoming monster jam and motor cross at Petco Park. M. Reed noticing arundo being removed near SD Mission Rd. R. Burg requests Councilman Sherman look into AG pool situation for Patrick Henry girl's water polo team.

All Peoples Church - Christian Burn (consultant) – Planning Commission approved update. Project submittal soon to be submitted. Consultants are looking at potential issues and working on submittal. Will come back before NCPI Board with submittal overview. M. Adams asked to remind everyone where church will be located (off College Blvd near Del Cerro Blvd).

Dan Smith – homeless widespread. Someone is going to die during rain event. Local businesses being flooded.

D. LaRaia – Where are homeless coming from? Living on edge of river.

Tommy H. - homeowner in AG. Election on Jan 27th 12-3 IBEW 465 7444 Trade Street to elect State Democratic Party delegates. Opportunity to go choose delegates. Brought along flyer.

T. Cords – No new info from city on revising recreation council policy. About one year behind. Review started on new city park master plan should last approx. 6 months. Kiwanis Club (AG/Grantville) putting on valentine sweetheart ball at AG Rec Center. \$10 per person. Center Director at AG leaving for job in El Cajon.

SDSU EIR 2019 NCPI Participation

-SDSU will begin their EIR Process for the Mission Valley Site in 2019. Seeking motion to allow NCPI to submit formal letter to SDSU requesting progress reports and community outreach.

Stephen Dahmes requested NCPI involvement. D. Smith reads statement from SDSU (get from David). J. LaRaia makes motion S. Grimes seconds 12-0 aye. Letter to include recommendations for adequate infrastructure to serve site and open space, impacts of ingress/egress into Grantville, student/other housing, timeline for CEQA and EIR documents. J. Wilson SDSU says SDSU President very supportive of community involvement and will be guest speaker at Del Cerro Action Council on March 26th group meeting. T. Cords not present for vote.

FY 2020 Capital Improvement Project Budget- NCPI Sub-Committee

-Tasked to work with the Council Office to identify which Navajo CIP projects are being proposed to be FY 2020 CIP Budget. Review active CIP projects in Navajo and compile list of 4 priority projects to be submitted to the Capital Improvement Program Review Advisory Committee (CIPRAC) and Councilmembers office for consideration.

Not yet been given survey monkey link. AG Rec center, Alvarado Creek, Library, Alvarado Canyon Rd. realignment, Pershing field redevelopment, Fairmont restriping, (ask David for other 2). Dan Smith asks Roarke Shanley about committee (ask about name) to get Councilman Sherman involved. 30% design gets grant opportunities. M. Reed would like to be part of committee needs to be some emphasis on transportation. Traffic going to be an issue once Grantville gets built out. Let us be proactive Navajo get more DIF money than any other local community. J. LaRaia says we can leverage other dollars. T. Cords believes Kaiser Hospital to be closing in a few years.
