Matt Adams – housing crisis ongoing, permit activity in SD down 73% for housing permits compared to Q1 last year, MF permits down 83%;

Dan Smith – CPC report; Capital Improvements; CPG training; planning groups working on updates; homeless housing alternatives

Dion Akers- SDSU West rep; recap of transportation meeting; 5/22 hosting community engagement event 6-8 at Mission Valley Library. In response, public comment re concern about elimination of freshman parking and community impacts; NCPI should consider residential permits requirement.

#### **Informal Presentations:**

All Peoples Church – Robert Heber, Pastor at All Peoples Church: Powerpoint presentation regarding background and proposed project; non-denominational community church with 900-1000 members, many who reside in Navajo; Marcela Escobar-Eck: presentation on website; project submitted 5/3 for Community Plan Amendment to add church designation and PDP for to allow church use and deviations (rezone not proposed, property will remain zoned SF); 900-seat sanctuary with both fixed and non-fixed seating; California Mission-inspired design; two entry points one with proposed intersection/traffic signal on College; deviation from 30-foot height limit for towers and cross; 371 parking spaces in both surface and structured parking;

#### **Board Discussion**

- Dahm: sanctuary used by non-church parties? Leased to anyone? Not in the plan.
- Livingston: parking structure within 30 foot setback? Still identifying setback requirements with City based on determination of what constitutes rear and side yard setback. Strip between houses and parking structure is 11 feet and approximately 5 feet from parking lot. Grading plan submitted with application; will present finished grade elevation next time.
- Livingston: parking lot and structure lighting? Will work with community on lighting and screening.

Adams; hours of operation/service times: 9:30 and 11 on Sundays; youth group meetings on Sunday nights; miscellaneous programs throughout the week (100 ppl max), typically 6-9;

Dahm: foot traffic on College?

Nielsen: CP land use designation maintained? Yes. Rezone required? No. Deviations

Wilson: lack of lighting on sidewalk on College; redo of median are major issues for

community;

Lance: grade differential issues relative to parking lot
