Elected Officials' Reports:

• Councilmember Scott Sherman (Liz Saidkhanian):

Gave update on repaving of streets in the district. Air b&b Ordinances passed by City Council this last summer were rescinded. Opponents to the new regulations gathered signatures and instead of placing it on the ballot, the Council decided to rescind the new regulations. So at this time, no regulations exist.

Need for a long term plan for the homeless—Councilmember is working to solve the problem.

Newly elected Councilmembers will be sworn in on Dec. 10.

Informal Presentations:

Accessory Dwelling Unit Ordinance – Edith Gutierrez, City of San Diego

Although prepared slide presentation could not be shown, Ms. Gutierrez discussed the State Mandates for Accessory units, City of San Diego Incentives and clarification of regulations. Summarizing presentation for materials later posted on Navajo website:

State Mandates: To encourage development of Accessory Dwelling Units, Governor Brown signed into law three bills: SB 1069, AB 2299 and AB 2406—Junior Units

- 1. No additional parking is required provided the CU is:
 - a. Located within ½ mile of public transit.

- b. Within an architecturally and historically significant historic district.
- c. Part of an existing primary residence or an existing accessory structure.
- d. Replacement parking could be tandem, on an existing driveway, and within setback
- 2. Fire sprinklers not required for CUs if not required for the primary residence
- 3. Existing structures converted to CUs with the appropriate meter size are not subject to additional water/sewer fees.

Incentives:

- 1. Neither the primary residence nor the CU **requires** it to be owner occupied.
- 2. One-story CU could encroach into the rear & side yard setbacks up to 30 feet.
- 3. No additional parking required provided the CU is:
 - a. 500 SF or less
 - b. One block from a bike shared station
 - c. Parking ratio was reduced from 1.0 spaces per bedroom to .5
 - d. Parking could be in any configuration including lifts.

Junior Units

- 1. A Junior unit category was added in compliance with AB 2406
- 2. A JU can be a maximum of 500 SF contained within the existing SFR
- 3. The primary residence or the JU must be owner occupied

Fees

1. Fees waived June 2018

12th Update—State Mandated

- 1. The GFA of an attached CU cannot exceed 50% of existing or proposed habitable dwelling unit.
- 2. Parking cannot exceed one parking space per CU.
- 3. CUs cannot encroach **in street** side yard.
- 4. A structure (1 or 2-story) cannot encroach more than 30 ft. in length.

Ouestions:

Marilyn Reed: How did the structure on Seaman Street get permits to be built? Ms. Gutierrez—I do not know.

Shain Haug—Why was this issue not brought to the Navajo Community Planners and other community groups for review and input? Mrs. Gutierrez: The changes to the Accessory Unit Dwelling Regulations went through a process of review as mandated by the City. Each step was always open to the public.

Old Business:

Dan Smith—a letter was handed out to board members which was authored by Justine Neilsen on behalf of the subcommittee on Transportation for the Navajo area. The letter addressed the lack of conductivity between Grantville and Mission Valley. Also, still of great concern is the flooding issue and concern regarding the lack of park space. The letter will be sent to Councilmember Sherman.
