

#### Annual Report for January – December 2007

#### I. Introduction

The official name of the San Ysidro community planning group is **San Ysidro Community Planning Group (SYCPG)** [formerly known as San Ysidro Planning & Development Group – SYP&DG]. The SYCPG is among the first of the City Council recognized community planning groups, in continuous operation since it's recognition by the City of San Diego in 1967.
