Provide Comments on the Notice of Preparation of a Draft Environmental Impact Report for the "Pipeline Safety and Reliability Project for a New Natural Gas Line 3602 and De-rating Line 1600" Proposed by SDG&E and the Southern California Gas

Company: The California Public Utilities Commission (CPUC) has initiated the public scoping process for the preparation of a draft Environmental Impact Report (EIR) to address the environmental impacts of the proposal to construct a 47-mile natural gas transmission line (Line 3602) from Rainbow to Miramar and retain but de-rate an existing transmission line (Line 1600) built in the 1940s. The new line would be installed in Pomerado Road as it extends through Rancho Bernardo; the existing line extends through various residential communities in Rancho Bernardo. The Notice of Preparation is the first step in the EIR process, providing the public with the opportunity to outline the range of issues that should be analyzed in the draft EIR. The Board will consider and act on issues for inclusion in a letter to the PUC respond to their Notice of Preparation. Comments regarding the scope of the draft EIR are due to the CPUC on June 12, 2017. To obtain a copy of the NOP and other information is available at http://sandiegopipeline-psrp.com.
