Modifications to Agenda (2/3 vote requirement to change Information items to Action Items prior to agenda adoption): L. Grucela proposes NCPI send letter to City of SD asking for public comment review period pertaining to ColRich project be extended for an additional 30 days D. Livingston seconds (7 aye 4 nay). M. Adams say NCPI discussed last month sees no need to revisit. Thinks requests for extension is likely one of the comments to the city. NCPI on record to being opposed. J. LaRaia understands request and states individuals can request extension does not believe it needs to be on the agenda. L. D. Smith shares copies of CPC Committee meetings. M. Adams shares his appreciation for all Dan's work on this matter.

#### **Informational Presentations:**

#### **Navajo Planning Group Flooding Subcommittee:**

Grantville Trolley Station/Alvarado Creek Enhancement Study Presentation of alternatives to address flooding issues on Mission Gorge Road

D. Smith discusses previous 5 yrs. working on subcommittee for project. Presentation made by Subcommittee group voted 9-0 in favor of going to NCPI for vote. Lisa Lind makes PowerPoint presentation (on memory stick).

M. Adams states NCPI willing to assist and get behind funding options. D. Livinston asks if properties have been purchased yet. NO still in planning stages. D. Livingston likes conceptual

bridges and potential promenades. Glad to see another culvert added under Mission Gorge. How does it impact properties on either side? WANTS TOMAKE SURE DESIGN DOES NOT AXERBATES EXISTING CONDITION. BUILDINGS MAY NEED TO BE BUILT UP (ON FILL). Has more vision/detail available. WORKING ON THIS VISION. J. LaRaia asks if project includes road re-alignment. Preliminary design ongoing for roadwork. NO TRAFFIC ANALYSIS CONDUCTED YET. M. Reed asks if ACOE weighed in on this yet NO. WILL DISCUSS WITH VARIOUS AGENCIES IN FUTURE. NEED TO USE CONCRETE CHANNELS DUE TO TOPOGRAPHY AND PROPERTY. Dan Smith states MTS has added fill to build Alvarado station. Discusses loss of property due to project (potential eminent domain). Doing best they can, elevations a constraint. Asks when they might be at agency level? IMPORTANT STEP FORWARD. STUDY TO WRAP UP IN END OF JULY. COOPERATION OF LOCAL PROPERTY OWNERS WILL BE VERY IMPORTANT. J. LaRaia mentions Austin TX. Suggests trying to create recreational opportunities. Create a usable river.

Audience member suggests property owners will be happy eliminating flooding but thinks traffic from the Twain Ave. apts. once completed will create a worse problem than flooding.

Dan Smith asks when it will become an action item. M. Adams states once report is completed and reviewed NCPI can have on as action item. Would like Board and Community to review prior.

J. Wilson one vote short. M. Adams would like Board to declare seat open and have election for Sept meeting. Dan Smith makes motion and T. Flodin seconds Motion to declare Del Cerro seat open hold special election during Oct meeting. 11-0 in favor. L. Grucela suggests holding election in Oct instead of Sept to allow more time for potential nominees to attend two meetings. D. Livingston would be in favor of that. J. LaRaia counters that we may be qualifying someone who has only attended two meetings. S. Grimes ask clarification for two meeting attendance prior to election. Does Oct meeting count as an attended meeting? NO.
