Speaker: Shari Collins: Concern about fire safety with the Junipers project. Children, disabled, are not going to have access to exiting the community safely. Suggest that any permit grant be contingent upon the development of a fire safety plan.

Speaker: K Kung: Spoke in opposition to the Junipers project.

Speaker: Joe Pierzina: Representing the PQ-NE Action Group. Spoke in opposition to the Junipers project.

Speaker: Marina Fomenkov. Ongoing request for information about the recreation facility at the Hotel Karlan.

Speaker: Ramesses Surban: Expressed concern and disapproval that the San Diego Planning Commission has approved the PQ Villages project *without adopting* the provisions recommended by the Rancho Penasquitos Planning Board. Expressed concern that the Rancho Penasquitos Community Plan is being generally disregarded by the Planning Commission.

Speaker: Phil Hoos. Expressed concern about freeway noise. Inquired as to whether or not the 33N development team has a mitigation plan for freeway noise.

 - Chris Cate is calling for a permit process for Short Term Vacation Rentals, to pay for enforcement of the codes.
 - Question: Is there a date for when the work is to get started at the Canyonside Rec Center?
 - Answer: No.
 - Rules Committee met. Proposal to increase taxes to use funds for affordable housing. Funds controlled by the San Diego Housing Commission. Estimated 5,000-10,000 units to be created. Plan calls for purchase & acquisition of property and construction of such.
