- 1. (6:32 pm) Hines Riverwalk Project Bhavesh Parikh from the Hines Corporation gave the LVPG a presentation and update on the Riverwalk Project in Mission Valley.
- 2. (7:18 pm) Social Advocates for Youth Prevention Programs Manual Andrade from SAY presented legislative land use objectives to keep drugs, alcohol and tobacco from San Diego Youth.

Action Items:

1. (7:32 pm) Sprint Tower at Jenny Craig Pavilion - Mark Phillips from Precept Wireless Consultants presented a neighborhood use permit application to modify an existing communication located on the USD campus. LVPG will vote whether or not to endorse the project.

Motion by M. Castro to endorse the project permit as presented, second by D. Beckham. Hand vote:

11-0-0. Motion carried.

2. LVPG Bylaws and Code of Conduct – LVPG viewed and discussed proposed changes that the Bylaws subcommittee drafted. LVPG will vote to include any proposed changes in the LVPG bylaws.

H. Wayne explained the proposed changes and the process to accept or deny the changes.

Item 1 – verbiage to change the "shall" (instead of should) attend "three of the past twelve" (instead of three out of six) meetings.

Motion by J. Carrol to accept this change, second by K. Warner. Amendment to the motion by C. Baker to strike "three" and change to "one" meeting to run for the Board. Hand vote: 2-9-0. Motion defeated. Amended motion to read "two" meetings. Hand vote: 8-4-0.

** 2/3 Vote to approve the changes. Hand Vote: 9-2-0. Amended motion approved.

Item 2 – Vacancy (aligning requirements)

Motion by D. Beckham to accept the proposed changes, second by K. Warner. Hand vote: 11-0-0. Motion carried.

Item 3 – Superannuated members: members who have exceeded the eight consecutive years on the board must receive a 2/3 vote to remain as board members

Motion by J. Carroll to accept the proposed changes, second K. Warner. Hand Vote: 10-1-0. Motion carried

Item 4 – Number of votes to be elected for any vacancy. A candidate must rec 5 votes in order to be elected to the vacant position.

Motion by C. Baker to accept the proposed change, second K. Warner. Hand vote: 8-2-0 (K. Heinle abstained due to missed discussion)

Item 5 – At-Large members (align our practice to the bylaws)

At-Large term is one year and must meet the same qualifications as those candidates running for the Board

Motion by D. Beckham to accept the proposed change, second by D. Perez. Hand vote: 10-1-0. Motion carried.

Item 6 – Code of Conduct for Linda Vista Planning Board members

Motion by K. Warner to accept the proposed Code of Conduct to further the bylaws, second D. Beckham.

Motion by F. Senoski to amend the proposal to be an appendix to the bylaws, second by C. Baker. Motion by J. Carroll to postpone acceptance of Code of Conduct to the June 2018 in order to conduct more research on other planning groups, second by T. Ogot. Hand vote: 8-3-0. Motion carried.
