- B. College-10# 21003732, Substantial Performance Review Process Two, for After the Fact emergency work conducted November 28, 2014. Work removed vegetation, sediment and debris in a 12 foot wide, 780 foot long concrete lined storm water channel.

 Discussion of how & to whom to distribute survey including: Use CACPB-CC newsletter, College Area News, single Constant Contact mailing & hand deliver to nearby properties. The whole community should participate but make sure those living nearby are notified. Should not distribute to whole student body. Survey should include respondent's address. Survey will go to Board for approval before it is sent. General consensus that should be part of larger Montezuma plan but accomplish it one step at a time.

III. LOCAL, STATE AND FEDERAL ELECTED OFFICIALS, LAW ENFORCEMENT, SDSU LIAISONS

- A. Roberto Torres for District 9, Councilwoman Georgette Gomez.
 - 1. Community Plan Update. College Area is high on list to get SANDAG grant money for plan update; will know decision at end of July. Data gathering can start as soon as funds are available. Overall, including time for community input, process can take 4-5 years to complete. The proposed specific plan is on the radar & is being considered, can't say more than that now.
 - 2. <u>Companion units.</u> We get a lot of calls about separate addresses for CUs, thus separate B permits. We will to work with the city to find remedy within state laws. We met some community members to brain storm about ideas & questions & have requested a legal review on CU issues. <u>Discussion:</u> Can garage conversions which are part of the original house have separate addresses?
 - 3. <u>SBMI property yard signs.</u> We've been in touch with SBMI but nothing has changed. We are trying to give them more leeway, then we'll move to code enforcement. It is slow.
- B. Mark Peterson, SDSU PD
 - 1. New student orientation starts tomorrow; it will increase traffic.
 - 2. Move in is August 23-4 traffic will be managed, e.g. lane by Chapultepec Dorm on Remington will be closed to traffic for move in.
 - 3. SDSU has no control over traffic problems caused by dorm construction on Remington as that is a public road not SDSU property.

C. Rachel Gregg, SDSU

New SDSU President, Adela de la Torre, began in June. She seems very community oriented. Schneider: I suggest all community groups join together to welcome her.

D. Jim Schneider, College Area BID

We celebrated opening of a new coffee shop. We are taking votes for favorite business awards

IV. NEW BUSINESS

A. Update on status of Tubman Joint-Use Park (Lee Dulgeroff, Chief of SDUSD facilities)

- 1. Joint Use Agreement. Tubman Village, an independent charter school, SDUSD & the City are all involved in approval of joint use project. School controls grounds when in session, it is a city park the rest of the time.
- 2. <u>Timeline</u>. Design funding late 2017. Proposal goes to School Board July 21, 2018; plans will be available for review that day. A favorable vote is expected. Construction may start in June 2019 & hope for occupancy first quarter 2020.

3. Concerns.

- This plan shows fewer trees than earlier. Dulgeroff: this is the plan we have.
- Concern that joint use parks only have a port-a-potty when soccer leagues play. <u>Dulgeroff</u>: that is a city park issue. These are not regional parks thus don't have separate restrooms.

B. Update on securing liability insurance coverage for CACC (Reynoso)

This requires becoming a 501c3 as Rolando Community Council has done. I have heard the IRS is reluctant to grant this to community groups unless they can show they provide a service. Will look into it further

V. TREASURER'S REPORT (Putman)

No income, Web fee only expense. June Total Balance: \$24,178.08, DPT fund: about \$776,719.92

VI. COMMITTEE REPORTS

A. Outreach Committee (No chair)

Cottrell suggests including annual financial statements, letters sent, committee minutes on the website and possibly CACPB/CACC minutes as well as link to them on city site. Such additions do not require Board vote. Cottrell will identify someone to create the structure for additions to be hired with funds approved earlier. Cottrell will post minutes and letters to the site.

B. Long Term Visioning and Beautification (Reynoso- unofficial, informal meeting)

Planning wants to reduce the 3-4 year time for revising a community plan to 18 months. Ours will be a focused plan update focused on Montezuma, El Cajon and College, so they are still considering the specific plan component. I committed to the former head of planning that if they move ahead quickly I will put a group together do a ground survey recording what exists. We need a lot of community input to brainstorm. I've spoken to Rolando, El Cerrito, Talmadge, Del Cerro, Grantville leaders asking to coordinate. They would be affected & we need their support. I'm planning a beer gathering at Ugly Dog on El Cajon at 7p.m. Aug. 8 to encourage a lot of discussion. Murphree: It is important that we all read the current community plan as background. The 1989 College Area Plan is on CACPB/CC website under board documents.
