San Carlos Village CUP #615707- Aaron Rodriguez, for 24 Hour Fitness

Process 3 Conditional Use Permit requested for the 24-hour operation of an existing one story 34,215 sqft fitness center at 8876 Navajo Road. No construction is proposed for this project. *Note: Fitness Use is allowed per Zoning, however operation times are limited. Applicant requesting deviation from zoning to allow for 24-hour operation.

Matt Adams—Motion to Approve, 2nd by Robert Weichelt

Discussion:

Lance Grucela—L.A. Fitness has been at this location for 15 years with hours 7 am to 10 pm. For this new facility, will there be security? Ans.: Security from 7pm to 10 pm on site, with drive-by security after 10 pm.

Dan Smith- Cycle Review had improvements. Are you going to do them? Ans.: Improvements requested by the City—not sure if they will be completed. Discussion is ongoing involving improvements to the driveways.

Dan Smith- What about the residential project close by? Ans.: Closest resident is 139 feet away—no noise increase seen. Distance from residential project is not seen as a problem for the residents.

Aaron Rodriquez—Estimated opening date is Nov. 3

Riverdale Site Development Permit #612608- Jeannette Temple Developer is the Atlantis Group

Site Development Permit for redevelopment of a restaurant site to establish a two-drive through eating establishment that is within CPIOZ B and deviates from CPIOZ A supplemental development regulations at 10370 Friars Road (Black Angus Restaurant.)

Site development permit lease expires in 12 months. The other restaurants and businesses not affected. In particular, CVS has a 30 year lease and is not giving up the lease. It is the closest drugstore to the Stadium property with low rent and high sales.

Projects proposed:

- 1. In-and-Out Hamburger Drive thru
- 2. Starbucks Drive thru only

Doug Livingston—Will you be keeping the mature trees on site? Ans.: Yes

Matt Adams—Impacts of two restaurants both with a drive thru can be significant. How does the design account for impacts of traffic? Ans.: Median on Friars Rd. will help control traffic. The cue for In-and-Out will be 19 cars. This will prevent problems. There should not be any impact to traffic or parking.

Dan Smith—What is the cue for Starbucks? Ans.: 9 cars

Justine Neilsen—What about required parking? Ans.: Both will be providing required parking.

What about blocking spaces? Ans.: With the cue for each improved from other restaurants of the same kind, this will not occur. Each will exceed the City's requirement for cars in the cue.

Matt Adams—Motion to approve site development permit with requirement of a full cue of 19 cars for In-and-Out as well as 9 cars for Starbucks. Additionally, the mature trees will be kept on site., 2nd by Dan Smith

Continued Discussion:

David Smith—Area could have potential for high density multifamily residential—we need more mixed use residential. Why was this not considered? Ans.: Limited on what can be done on site due to the 30 year lease.
