### **Item 6.** Action Items

**101. Genesee Ave. Sidewalk Improvements – PTS:620031** (Hong Le) A site development permit required d/t impact on coastal sage scrub. Installation on east side between Sauk Ave & Chateau Dr with a retaining wall

and revegetation of slope with native species. Presentation reviewed existing conditions and rendering of completed project includes sidewalk, a hydraulic disconnect strip filled with cobble that allows runoff to percolate through soil rather than enter storm drain, also new curb and gutter. Construction to begin late 2019, lasting approx. 6 months.

Kevin, as chair of Project Review Sub Committee, states is appreciative that this project came before community because it significantly impacts character of our community and hopes that all similar projects will also come before community even if not required. Notes that this was a CIP project identified by CCPG for several years. Reviewed motion made by PRS to recommend approval with conditions and recommendations regarding aligning horizontal panel joints, increasing plant sizes to 5 gallon for 3 species, using pile installation method that avoids vibration impacts to nearby residences, installing bike lane improvements on Genesee simultaneously, and preventing bike/scooter play in brow ditch.

Questions by Board regarding cobbles, brow ditch, type of fence atop wall, plant size and maintenance, noticing of neighbors, and traffic impacts during construction were responded to.

Question by public re possibility of widening roadway? Resp: Limited by right of way.

A restoration ecologist clarified that larger plant size would not improve success of plantings and could increase erosion concerns.

Motion made by Kevin to recommend as per PRS (above), second by Susan.

Motion by Billy to amend by deleting condition to increase plant size, second by Delana.

## **VOTE ON AMENDMENT: 8-4-0, Motion passes.**

Kevin clarifies motion: To recommend approval with the following 3 conditions and 1 recommendation. Conditions: 1) Align horizontal joints from one concrete panel to the next 2) Use a method to install H piles that does not cause vibration to the adjacent residences 3) Provide means of preventing bike and scooter traffic in the brow ditch.

Recommendation: 1) Include bicycle facility upgrades to Genesee concurrent with this project.

# VOTE: 11-1-0, Motion passes.

# **102. Recommendation of Final Draft Balboa Ave. Station Area Specific Plan** – (Michael Prinz, Senior Planner, City of San Diego, <a href="majorizr@sandiego.gov">mprinz@sandiego.gov</a>)

Represents 210 acres on both east and west side of I-5 adjacent to Balboa Trolley Station. Plan identifies land use & mobility improvements in City of San Diego and access to the station. Goals: Implement General Plan of City of Villages, capitalize on mid-coast trolley extension, increase housing in transit priority area, and improve pedestrian & bike access to the trolley station. Review of plan components including existing conditions, proposed land uses/densities, roadway changes, bicycle/pedestrian infrastructure, 240 parking spaces at station and bus connections. The recommendations made by Balboa Station Sub Committee included:

Implement the Medium Density Alternative included in the PEIR;

Prioritize infrastructure improvements;

Establish a cap of 2000 units prior to construction of a pedestrian bridge;

Provide an improved intersection at the Balboa Avenue/Morena Boulevard intersection;

Implement traffic mitigation measures in Clairemont.

Replace cycle track with Class II bike lanes on both sides of Morena Blvd.

These already presented to Planning Commission. Balboa Spec Plan will go before Land Use & Housing Committee on 2/6, then to City Council (date TBD).

### Sub Committee comments:

Harry (chair) Expressed thanks to SC members. Station is an "island" without ped I-5 overpass.

George H.: States no support at Planning Comm for our recommendations. Is uncertain of own support today.

Donna R.: Felt SC pressured to make recommendation which is only a "draft". New bridge is crucial.

Susan: Voiced concerns about E-scooters in cycle track? Memo re 4 lanes on Morena? Resp: City rules will apply but none formalized yet. Memo applied only Morena Spec. Plan area.

Board comments:

Barb: Opposes bike lane on one side, concerned about safety and visibility in abutment space, must secure ped bridge funding agencies, encourages public art opportunities.

Margie: Support median with turn lanes rather than free turn lane, concern that some buildings on Balboa abut sidewalk limiting ability to provide bicycle paths and that mature trees removed. Resp: Will be greater setbacks on Balboa for greater public space with redevelopment & replacement of trees is SANDAG responsibility.

Kevin: Need signage for pedestrian pathways & Santa Fe intersection dangerous. Resp: Those improvements recommended. Plans for abandoned cloverleaf space? Resp: Potential for park/open space, to address in CPU process. I-5 abutment space must await need for substantial improvements in Plan area? Resp: True.

Billy: I-5 overpass should be at Magnolia. Must have cycle track for safety, component of bike path from Oregan border through Calif in railroad right of way, California Rail Trail.

Richard: Bridge is necessity, City takes input but does not implement.

Matt: Ped overpass is greatest concern.

Naveen: Questions why change cross section of Morena in different segments.

Public comments included support for ped bridge, concerns that north of station cycle track will become Class II bike lanes both sides. No sidewalks on east side of Morena from Avati; Resp: are on City's capital improvements list, unclear timing of implementation. Concern that many properties in PB portion have recently been redeveloped so street infrastructure of multi-use pathway will be non-contiguous.

Motion by Harry to continue item until receive response from SANDAG, second by Richard.

VOTE: 4-7-1 (Delana abstains d/t unable to reach decision). Motion fails.

Motion by Matt to approve Balboa Station Specific Plan with conditions as recommended above with additional requirement to identify lead agency and funding source for pedestrian bridge.

Billy suggests removing Class II stipulation and retaining cycle track on Morena south of balboa station, accepted by Matt. Second by Delana.

#### Clarification of motion:

Recommend approval of Balboa Station Area Specific Plan with the following conditions:

Identify a lead agency and funding source to implement the pedestrian/bicycle bridge;

Implement the Medium Density Alternative included in the PEIR;

Prioritize infrastructure improvements;

Establish a cap of 2000 units prior to construction of a pedestrian bridge;

Provide an improved intersection at the Balboa Avenue/Morena Boulevard intersection;

Implement traffic mitigation measures in Clairemont.

VOTE: 11-1-0, Motion passes.

Motion by Nick to extend meeting time, second by Barb.

## 202. City of San Diego Citywide Tree Planting Program – (Lesley Henegar, <a href="mailto:lhenegar@sandiego.gov">lhenegar@sandiego.gov</a>)

Part of implementation of CAP. Top three most effective initiatives to advance CAP are using transit, reducing land fill emissions, and planting trees. Numerous health and economic benefits to increased # trees. Goal for 15% canopy by 2020, 35% by 2035; current canopy is 13% citywide, Clairemont is 16.8%. Need equivalent of 4 Balboa parks fully planted. Can apply for free tree to be planted in City ROW of single or multi-family properties. Streets division has funding for 1000 trees. Encourage additional independent tree planting on private property.
