We have been informed that the July 26 Traffic Study has been pushed off until Year-end 2019 per Justine Murray. Plans will show different alternatives—"allow discussion within the Community to decide which alternative is preferred." Since CIP funding was dropped from City Council D1 plans, where is the funding coming from? Does, in all likelihood, a Ballot Measure need to be provided? If property tax assessment base is used, local businesses will control vote, not local residents.

Timing, available space is at a premium especially January 2020 (school closure). TPCPB election is in March 2020 and new officers by April 2020.

- 1. Request for funding for **Torrey Pines Community Plan** current and near term critical issues. Informed that request **passed** onto senior Management but **TP** is not on any forecasted plans. Two adjoining bordering CPs are being worked on. Board will now have to review DEIR's when issued.
- **2.** Ad Hoc committee to study and advise Board on all matters related to City Traffic Report on Del Mar Heights Road and Public Safety. Road analysis was <u>not provided</u> by July 26. Putting road on a diet may require removing parking completely on the western end from Nob to Crest Way. (46 spaces)
- 3. City Council Appeal project 559038 on Monday September 16th MO at 11198 STE3 Sorrento Valley Rd. at 2:00 PM
- **4.** City Council Appeal project 624232 @ 13796 Durango St October 8th at 2:00 PM— CEQA notice issued before PRC/TPCPB ever publicly reviewed project as DSD Cycle review not completed. Issue is allowing a driveway entrance/exit onto Del Mar Heights Rd.

Action:

1. 10325 Roselle St. Project 150566 – originally approved March, 2008 (11 years ago) Action is to **Rescind** the Board's approval of project. Now. We

learned that on July 17, 2009, the San Diego Resources Board designated this site as **Village of Ystagua**, **Area #1 as a historical resource under HRB Criterion A.** "The resource exemplifies special elements of City's archaeological and cultural development associated with prehistoric habitation of CA-SDI-4609." Information (CA-SDI-4609) and SDI-4513 (testing) were available in 1989 but *never provided* to Board nor were documents related to a legal matter.

2. Notice of Right to Appeal Environmental Determination: Peace Law Firm @ 2236 Carmel Valley Rd. Project 625754 A 5,634 Sq ft. - Coastal review Action: Requesting Board approval to Appeal to City Council via DS 3031 under CEQA. (based upon 10 day notice from DSD/City Clerk if notice is prior to next scheduled Board meeting and does not allow for notice within 10 day period).
