 - Information on Boulevard Bus Way, Rte. 215 Bus & Bike only lanes on El Cajon from Fairmount Ave. to Park Blvd.
 - State of District speech Jan. 29
 - Complete Communities, Mayor's proposal to facilitate affordable housing & meet climate action plan, doesn't rezone but changes some formulas. Currently EIR is available for review & planning groups can submit comments in January
 - Hamilton: We can't make comments without presentation & the deadline is before our next meeting. That deadline needs to be extended so community groups can review & respond.
 - Library parking agreement with adjacent hotel had 2nd reading; construction will begin in about a year
 - Paving of Fairmount Ave. up to Collwood Blvd. is supposed to happen in late January.

D. Jim Schneider, BID:

- Introduced new businesses.
- Make it Market, local craftspeople Jan. 18 11-3 at Himalayan Yak & Yeti.
- Happy hour with community leaders from communities who don't usually meet, to identify common interests.

D. Rachel Gregg, SDSU:

- Spring move in Jan. 20 weekend should not be major disruption.
- I am campus census coordinator we are working on strong outreach. Residents can do census on computers at SDSU library.
- Good Neighbor Brochure, expanded, is being printed.
- Welcome idea of community representatives welcoming students at move in, and willing to help develop that.

VI. President's Report: Reynoso

- A College Triangle has door hanger with information on trash collection, will try to make it available throughout College Area.
- B. Candidate Forum, for all candidates in College Area races are invited to forum at Faith Presbyterian Church January 24, 6-9 p.m.

- A. Update on comments received on steering committee report on community plan update project & next steps: Reynoso
 - Community Plan vision is on line & open for comment. The original deadline of Jan. 31 has been extended. The plan steering committee will review all comments, make any changes based on feedback & send to board for vote at February meeting before presenting it to the Planning Department.
 - 1989 community plan section reports. Comments are summarized in minutes. Section reports should be sent to Murphree to be combined into an overall report.

B. Upcoming board elections: Reynoso

- Six seats will be open: Boyd, Cook, Hoeger, Nystrom, Silva, & currently vacant seat.
- City is likely to change eligibility rules, but ours are still in effect this year.

C. Report on 501(c)3 Status: Reynoso

- College Area Community Coalition was established as separate non-profit corporation to handle funds. The existing CACC will be a project of the coalition.
- The Coalition board (Bevier, Cook, Jennings, Murphree, Nystrom, Putman, Reynoso)

- approved bylaws & opened an account at a different bank from the CACC/PB bank.
- \$1500 was transferred from CACC account to Coalition account as a loan to open its account.
- New member dues paid via the website will go to the Coalition account. Membership form will say dues may be tax deductible, which we hope will encourage larger donations.
- The Coalition will raise funds-- dues, grants etc.—to fund CACC projects. CACC can take on more & bigger projects because of ability to get insurance as non-profit corporation.
- *Murphree:* We should be thinking about projects for which we might get grants, e.g. tree planting. We should think about projects & grant sources. *Schneider:* It is important to develop attainable project ideas first, then get funding, rather than prioritize funding.

VII. Treasurer's report: Putman

- November & December reports sent by email. Balance 1/1/20 is \$17,358.86
- We need to decide mechanism for reporting the loan to Coalition
- Membership dues, collected by the Coalition, will be transferred to CACC.
- Move to set up an inter-entity account to facilitate transfer between Coalition & CACC & to book a loan from CACC to Coalition to open an account: Putman Second: Silva Y:14 N:0 A:0 *Carried

VIII. Committee reports

- A. Community Outreach Committee: Amerling
 - Membership Drive: Do we want to continue snail mail (\$500) or just use social media/internet? If snail mail it would be in February & require changed wording to reflect membership goes to Coalition & identifying its non-profit status.
