PUBLIC SERVICE ANNOUNCEMENT REGARDING MEETING ACCESS

HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by

dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first.

Those participating virtually may NOT cede time to others participating in person or virtually.

HOW TO PROVIDE WRITTEN COMMENTS:

For Agenda Items and Non-Agenda Public Comment: Submit using the [webform](#), indicating the comment type and item number (if relevant). Comments must be submitted the business day prior to the meeting to be distributed to the Hearing Officer and posted online with the meeting materials. All webform comments are limited to 200 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Please go to the Hearing Officer [website](#) for further instructions.

Written Materials: Instead of submitting materials as an attachment to the [webform](#), you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Please Note: Documents related to the Hearing Officer meeting agenda items which are distributed to the Hearing Officer prior to the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 1st Floor, San Diego, CA. 92101.

Late-Arriving Materials:

ITEM 1: THE GRANT AT MISSION TRAILS – PROJECT NO. 1097856

Plan Area: Navajo

Site Development Permit for the demolition of an existing two-story commercial building and construction of one seven-story building with 48 multi-family dwelling units totaling 55,620 square feet located at 5945 Mission Gorge Road. The 0.40-acre site is the CC-3-9 Zone, Airport Land Use Compatibility Zone (Montgomery Field), Airport Influence Area (Montgomery Field, Review Area 2), Community Plan Implementation Overlay Zone – Type A (CPIOZ-A), FAA Part 77 Noticing Area (Montgomery Field, 572 to 577 feet above sea level), FEMA Floodways & Floodplains (100-Year FEMA Floodplain/Flood Zone AE), Transit Area Overlay Zone, and Transit Priority Area within the Grantville Specific Plan Area of the Navajo Community Plan Area. The project site was previously analyzed within the certified [Grantville Focused Plan Amendment Final Environmental Impact Report \(EIR\) No. 346289/SCH No. 2013111017](#) for the Navajo Community Plan. An evaluation was prepared to determine if conditions specified in California Environmental Quality Act (CEQA) Statute and Guidelines, Section 15183 would require preparation of additional CEQA review. The evaluation determined the project would not result in any project-specific significant effects that are particular to the project or its site beyond that identified in the certified PEIR. ITEM 2: *CT HOMES – PROJECT NO. 557456

Plan Area: Greater North Park

Site Development Permit and Neighborhood Development Permit for the development of one two-story, 2,643 square foot single-dwelling unit with an attached garage on a vacant lot which contains Environmentally Sensitive Lands (Sensitive Biological Resources). The 0.12-acre site is located at 2385 Felton Street within the RS-1-1 zone of the Greater North Park Community Plan Area, Very High Hazard Severity Zones, Airport Influence Area (Review Area 2), and the Federal Aviation Administration (Part 77) Notification area.
