HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by

dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first.

Those participating virtually may NOT cede time to others participating in person or virtually.

HOW TO PROVIDE WRITTEN COMMENTS:

For Agenda Items and Non-Agenda Public Comment: Submit using the [webform](#), indicating the comment type and item number (if relevant). Comments must be submitted the business day prior to the meeting to be distributed to the Hearing Officer and posted online with the meeting materials. All webform comments are limited to 200 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Please go to the Hearing Officer [website](#) for further instructions.

Written Materials: Instead of submitting materials as an attachment to the [webform](#), you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Please Note: Documents related to the Hearing Officer meeting agenda items which are distributed to the Hearing Officer prior to the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 1st Floor, San Diego, CA. 92101.

Late-Arriving Materials:

ITEM 1: CARVALHO DE MENDONCA – PROJECT NO. 690811

Coastal Development Permit and Neighborhood Development Permit to demolish an existing 2,035-square-foot single dwelling unit and portion of existing garage and construct a new two-story, 4,298-square-foot single dwelling unit with basement, attached garage, balcony and decks for a total gross floor area of 9,858 square feet at 6208 Avenida Cresta. The 0.20-acre site is in the RS-1-5 Zone, Coastal Overlay Zone (Appealable Area), Coastal Height Limit Overlay Zone, Transit Area Overlay Zone, and Transit Priority Area within the La Jolla Community Plan area. The project was determined to be categorically exempt pursuant to Section 15302 (Replacement or Reconstruction) of the California Environmental Quality Act. There were no appeals to this environmental determination.

ITEM 2: 8445 AVENIDA DE LAS ONDAS – PROJECT NO. 1050498

Plan Area: La Jolla

Site Development Permit for an addition to an existing two-story, 3,963 square-foot single dwelling unit located at 8445 Avenida De Las Ondas. The project includes demolishing portions of the unit and constructing a 1,995-square-foot addition with a new garage for a total of 5,447 square feet. The 0.46-acre site is in the La Jolla Shores Planned District – Single Family Zone, Coastal Overlay Zone (Non-Appealable Area), Coastal Height Limit Overlay Zone, Parking Impact Overlay Zone, Fire Hazard Severity Zone, and Geological Hazard Area 53 within the La Jolla Community Plan Area. The project was determined to be categorically exempt pursuant to Section 15303 (New Construction or Conversion of Small Structures) of the California Environmental Quality Act. There were no appeals to this environmental determination.

ITEM 3: 7755 ARJONS DRIVE CPF – PROJECT NO. 1104861**Staff:** Tyler Sherer**City Council District:** 6**Plan Area:** Mira Mesa

Conditional Use Permit application for a cannabis production facility at 7755 Arjons Drive in the IL-2-1 zone within the Mira Mesa Community Plan area and Council District 6. The project was determined to be categorically exempt pursuant to Section 15301 (Existing Facilities) of the California Environmental Quality Act. [Report No. HO-24-007.](#)

ITEM 4: VERIZON NIMITZ – PROJECT NO. 1055823**Staff:** Andrew Razon**City Council District:** 2**Plan Area:** Peninsula

Conditional Use Permit for the modification of a Wireless Communication Facility (WCF) by Verizon. The project consists of replacing six (6) existing panel antennas and installing six (6) new Remote Radio Units (RRUs), four (4) new raycaps and relocating three (3) existing RRUs. Additionally, the project includes modifications to ancillary equipment for support to the WCF. The antenna level equipment is located inside an existing dormer and faux chimney within screen enclosures concealed on the building roof and the existing 209-square foot equipment enclosure is located on grade. The WCF is located at 1475 Catalina Boulevard in the Residential Single Unit Zone (RS-1-7), the Coastal Height Limit Overlay Zone and FAA Part 77 Noticing Area of the Peninsula Community Plan area. The project was determined to be categorically exempt pursuant to Section 15302 (Replacement or Reconstruction) of the California Environmental Quality Act on April 28, 2023 and the opportunity to appeal that determination ended May 12, 2023.
