**HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:**

**In Person for Agenda Items and Non-Agenda Public Comment:** Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

**Via Virtual Platform for Agenda Items and Non-Agenda Public Comment:** When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by

dialing \*9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial \*6 on your phone.

**Please Note:** Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first.

***Those participating virtually may NOT cede time to others participating in person or virtually.***

#### **HOW TO PROVIDE WRITTEN COMMENTS:**

**For Agenda Items and Non-Agenda Public Comment:** Submit using the [webform](#), indicating the comment type and item number (if relevant). Comments must be submitted the business day prior to the meeting to be distributed to the Hearing Officer and posted online with the meeting materials. All webform comments are limited to 200 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Please go to the Hearing Officer [website](#) for further instructions.

**Written Materials:** Instead of submitting materials as an attachment to the [webform](#), you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Please Note: Documents related to the Hearing Officer meeting agenda items which are distributed to the Hearing Officer prior to the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 1st Floor, San Diego, CA. 92101.

#### **Late-Arriving Materials:**

**Plan Area:** Navajo

Site Development Permit for a new two-story 117,510 square foot self-storage facility building with a basement, a lease office and associated site improvements. The 1.7-acre site is located at northwest corner of Princess View Drive and Mission Gorge Road the IL-2-1 Zone within the Navajo Community Plan Area. The applicable site overlays include Montgomery Field Airport Influence Area 2, Community Plan Implementation Overlay Zone Type A (CPIOZ A), and the Prime Industrial Land Overlay, Very High Fire Hazard Zone (VHFHZ), and Federal Aviation Administration (FAA) Part 77 Noticing Area. This project was determined to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA State Guidelines, Section 15332 (In-Fill Development Projects). **ITEM 2: FRONT & A OFF-SITE ALCOHOL SALES – PROJECT NO. 1109526**

**Plan Area:** Downtown

Conditional Use Permit for the sale of alcoholic beverages for off-site consumption within a proposed 49,359-square-foot grocery store located at 201 West A Street on the ground level of the “Front & A” mixed-use development, under construction on the full-block site bounded by West A, West B, Union, and Front Streets within the Public/Civic land use district and Employment Overlay of the Centre City Planned District, the Airport Land Use Compatibility Zone, Transit Priority Area, and the Civic/Core neighborhood of the Downtown Community Plan area. The project is consistent with the previously certified [Downtown Final Environmental Impact Report](#) as amended and no additional environmental document is required under the California Environmental Quality Act. **ITEM 3: DISH SUNSET CLIFFS – PROJECT NO. 1070499**

**Plan Area:** Ocean Beach

Conditional Use Permit for a new Wireless Communication Facility (WCF) to install (3) new antennas, (6) Remote Radio Units (RRUs) behind Fiberglass Reinforced Panel (FRP) screens painted to match on the facade of an existing building (Masonic Temple) with equipment cabinet inside an existing enclosure on the ground. The site is located at 1711 Sunset Cliffs in the RM-1-1 Zone, Coastal Non-Appealable-2 overlay zone of the Ocean Beach Community Plan. The project is categorically exempt from CEQA pursuant to CEQA State Guidelines, Section 15303 (New Construction). [Report No. HO-24-023](#).
