We are supplementing SDPD in the community if asked, but otherwise we don't patrol off campus.

B. Sanna Loando, representing Gomez, Council District 9

- 1. Report on City Council
 - a. Extended: eviction moratorium to September 30, businesses can operate outside, parking enforcement suspension to October 1.

2. College area

- a. Slow Streets pilot program on Saranac. Slow streets is being done throughout the city on a rotating basis; Saranac will open again. We realize there was insufficient outreach in advance leading to much confusion.
- b. City Projects: Reservoir Storm Drain project work is complete, Tubman Joint Use Park opened
- c. Large item trash drop off Fri Sept. 25 8 to noon in SDSU parking lot 17c
- 3. Comments, questions
 - a. *Troy Murphree*, Tubman park gates are still locked at night, Slow Streets signs on Saranac have been stolen or knocked down by irate neighbors.
 - b. *John Putman*, Is there update on request to remove parking on Montezuma? *Loando*. We've spoken to Mayor's office. They want letters of support from stakeholders.
 - c. *Jim Schneider* What is the process for selecting slow streets? *Loando* There was a place on city web to suggest and CD9 did survey & submitted top five most requested. Saranac was one of them.

C. Jim Schneider, College Area Business District

- 1. BID video of annual awards event & celebration it is on BID youtube
- 2. Developed youtube series "Corbin on the Street" introducing 12 college area businesses bi-weekly.
- 3. In conjunction with the community plan update we have a locate here campaign to attract good businesses to commercial corridor
- 4. We're working with AS on Aztecs Rock Hunger, getting businesses to help raise money.

D. Armando Sepulveda, Associated Students

- 1. Aztecs Rock Hunger will be Sept. 28 through Oct. 18. Donations can be made online sdsu.edu/aztecsrockhunger or at Starbucks on campus.
- 2. Acquaplex & gyms are open for outdoor recreation, but because of current COVID lock down they're not show as open. Students are encouraged to stay in and stay distant.
- 3. AS is working with other student groups to create a COVID 19 information wellness video to for groups to distribute to members
- 4. Aztecs Rock the Vote, We hope to collaborate with CACC on this to reach students.

E. Rachel Gregg, SDSU

- 1. Mission Valley campus broke ground in early August & starting construction
- 2. Semester started with about 8,000 students. Due to the virus the 2,400 in dorms have been ordered to stay inside and the approximately 200 in-person classes have been paused for a month. ARC activities are outside, by appointment. There is a lot of outreach to students about the virus.
- 3. Party issues Interfraternity Council has issued a social moratorium all events are virtual. SDSU has added measures to deal with off campus parties. Because police are understaffed we have 2 Elite Security & 2 Red & Back shuttle cars patrolling Thursday through Saturday nights. They can record and report parties as can students and neighbors calling or using form on SDSU web. We've sent over 450 letters of violations. Violations can lead to disciplinary action up to suspension or even expulsion.
- 4. SDSU has a public county COVID testing site.
- 5. Arts alive is presenting SDSU virtual theater & concerts for \$5 general admission.
- F. Matthew Gordon representing Assemblymember Gloria reported state legislation this year

VI. President's Report: Reynoso

Julie Hamilton has volunteered to ask bike coalition for letter support on Montezuma parking elimination. We are following up on letters of support on this.

I am disturbed that we have created something to benefit CACC over which CACC apparently has no control. I would like a vote soon mandating monthly transfer of all funds above \$1,500 from Coalition to Council.
