A. William Perno, SAY San Diego Alcohol, Tobacco Drug Prevention regarding Councilmember Whitburn's proposed Cannabis Retail Outlet Amendments Proposal

- 1. Whitburn proposal removes current requirement of 1,000 foot separation of cannabis retail outlets from all local sensitive use restrictions currently in S.D. ordinance.

A. 6440 El Cajon Blvd. sewer easement vacation project:

B. CACPB Elections: Jennings

Elections will be held March 9. Thirteen seats are open: 1-1 year, 7-2 year, 4-3 year. This is because 2021 elections were COVID postponed; those termed out last year served an extra year creating the 2 year seats.

#### V. Committee Reports

- A. Community Plan Update: Montana
  - 1. The plan update is scheduled for mid 2023.
  - 2. 2 Proposals are to accommodate doubled population projected in 30 years.
    - a. Grand boulevard proposal in response to community & CACPB input before city got involved focuses density along 3 major corridors (El Cajon Blvd., College Ave., Montezuma Rd.) & mixed use in 3 nodes at intersections of those corridors
    - b. City staff proposes a "15 minute neighborhood" with less density on corridors, nodes & focus more density in the heart of the community. That presentation will be on website www.plancollegearea.org.(documents & presentations) I encourage everyone to look at it to see what staff is proposing.
    - c. City is doing a survey for community input. It was not widely announced so deadline was extended to end of March. Critically important to respond & write comments, surveys are set up to agree with their position!

### VI. Delegate Reports

A. CPC: Bevier

- 1. Mayor's Build Better San Diego for capital improvement projects. Gloria says in past not much of this money has gone to underserved communities (south of I-8) because DIF funds stay in communities where generated by new projects; with little development in older communities there's been little DIF funding. He proposes from now on pooling DIF to spend where most needed. City is developing scale to help determine greatest need (underserved area, housing, climate priorities etc.) To get public input a virtual public forum will be March 10 & there's another survey on www.sandiego.gov/buildbettersd web page (3rd item under get involved). This was not advertised so deadline is extended.
- 2. City's effort to get rid of PBs & CPC; there have been several sources of criticism of boards & City Attorney has concluded that PBs as advisory to city need to be similar to other advisory groups in city charter; To make them legal a lot of new requirements are proposed or PBs including not being informed of development projects. CPCs advice to PBs is to make sure March elections have nothing can be criticized.
