- May is budget month; all city departments are required to present their budgets at reported dates
- City of San Diego budget is 4.9 billion. Priority will be given to roads and infrastructure.
- SAFE act, which prevents flavored tobacco sales to minors
- Short term rental updates announced
- Issues pertaining to the Parks and Recreation department are now on the Get It Done app and website
- Street racing still acknowledged to be an issue
- Questions were asked about the following:

- Status of realigning Morena Bl to increase pedestrian, bike and trolley ridership: Answer was any work must wait until Morena Bl is repaved.

- Councilmombor I
- Councilmember LaCava wants to keep Planning Groups in operation and that Planning Groups maintain their independence

- Planning Groups will maintain ownership of their own documents

# 602: Water Main Improvements, Pedro Melo Rodriguez, PE, City of San Diego Engineering & Capital Projects Department, <a href="mailto:PMeloRodrigu@sandiego.gov">PMeloRodrigu@sandiego.gov</a>

- Project title is Clairemont Mesa East Improv 2, which replaces aging water mains and sewers
- Map was displayed depicting areas affected, including Clairemont Mesa Bl and residential streets between Clairemont Mesa Bl and Balboa Ave.
- 5 day advance notice will be given before construction starts in affected areas
- In residential areas construction will be done between 9AM and 5PM
- On Clairemont Mesa Bl construction will be done at night
- Street parking restrictions are expected
- No street closures are planned
- Sewer and water services is not expected to be affected
- Staging areas will only be temporary in areas immediately adjacent to work
- Start spring 2023, done fall 2024

# 603: Bike Lane Improvements, Everett Hauser, Program Manager, City of San Diego Transportation Department, <a href="mailto:ERHauser@sandiego.gov">ERHauser@sandiego.gov</a>

- Project will be bundled with Clairemont Mesa East Improv 2 pipeline project for economical reasons
- Currently sections of Clairemont Mesa Bl west of I-805 have no bike lanes; bike traffic is mixed with car traffic
- Street safety is a priority
- Class 2 bike lanes will be implemented for all of Clairemont Mesa Bl West of I-805 and Class 4 where feasible
- Questions were asked about the following:
  - o Bike lane improvements on Genessee
  - Bike lane improvements for Balboa Ave east of I-805 are not currently planned, repaving probable in next year
  - o Bike lines extending over the I-805 bridge
