  - a) First Review cycle documents discussed at the February 25<sup>th</sup> meeting. Discussion took place about "where we are," etc.
  - b) Bonus density is not factual.
  - c) Conflict between land use and zoning.
  - d) Affordability comes down to investors.
  - e) The next meeting will be the most important. The Subcommittee will be discussing/making Environmental Argument and its cumulative impacts.

- N. Park & Ride/New Pointe Subcommittee Report Chairperson, Brian Hollandsworth

  - 2. Plans still contain 50 units.

    - a) Interior open space: short by 100 ft.
    - b) Height of overall building 76 ½ ft. (higher than 70 ft. requested).
    - c) There is not a good sewer/water plan in place to date.
    - d) TPA causing all sorts of problems.
    - e) Lot needs to be re-stripped, which would bring units to 50.
