I. COUNCIL DISTRICT 1 REPORT - Richard "Ricky" Flahive, Office of Councilmember LaCava Ricky Flahive reported the following:

Ricky Flahive provided a report:

- There will be two budget townhall meetings May 2 (virtual) and May 21 (in person at Nobel recreation center). Now is the time for the community to identify what they would like to see budgeted.
- The Pacific Highlands Ranch Library and Solterra Vista Park is expected be open in the third quarter 2024.
- It was noted that Council District 1 has a budget for Public Good Needs and \$900 was provided to Del Mar Mesa for neighborhood watch signs. Ricky can be contacted for needs of similar scale.
- There is a board seat opening on the Park & Recreation Board.
- Ricky has office hours every Wednesday at noon.
- Kathleen Farrier attended to help answer questions about Community Planning Group reform.
 - Kathleen noted that materials are available at the website: https://www.sandiego.gov/citycouncil/cd1/policies-priorities
 - The proposal went to Planning Commission in February and Land Use & Housing in March; they will be going to City Council early this summer.
 - The policy namely proposes a legal separation between the City and Community Planning Groups

- Kathleen noted that the reform proposes that Community Planning Groups will continue to be able to meet at City facilities, City have staff members can still attend some or all of the meetings, annual stipends will remain at \$500, previous attendance to run or vote will no longer be required, and \$1000 to appeal will no longer be waived.
- Debbie Lokanc and Chair White both expressed concern about Board members having to absorb appeal costs to represent the community.
- Barry Schultz suggested that the City obtain some data regarding the amount of appeals by planning boards. Barry also asked about the two-year term-out and requirement that a robust outreach requirement is encouraged but there is no specificity what is expected.

J. MAYOR'S REPORT - Matt Griffith, Office of Mayor Gloria

Matt Griffith provided a report:

- The Mayor has proposed budget for Fiscal Year 2023 at \$8.9 Billion. A link to the proposed budget was provided: https://www.sandiego.gov/finance/proposed.
- Chair White asked Matt to join a conversation with Chair White and Barry Schultz regarding Livability and Village Loop Road.
- Debbie Lokanc asked about an incident where residents parking in Rancho Penasquitos weren't notified when streets were going to be paved. Matt responded explaining that he was not aware of the incident but the Mayor's office has made some recent remedies on communications with residents.
- Matt's noted his email GriffithM@sandiego.gov in the chat notifications.

K. COUNTY SUPERVISOR'S REPORT – Office of Supervisor Lawson-Remer

Jeff Yuen from the Office of Supervisor Lawson-Remer provided an update:

- Jeff explained eligibility programs still exist where 1 in 3 people can benefit, and Jeff provided a weblink in the chat notifications (see further below).
- San Diego County is making a commitment on affordable housing, and Jeff noted that the County is looking for public land to re-purpose for public housing.
- The County is building a 150-bed facility on County land in Midway for mentally challenged individuals. Onsite experienced mental health support staff is proposed.
- SMRP funding is continuing from last Spring grant workshop last month. Groups, especially non-profits can meet with the County's grant liason.

Dish Wireless: Consider the installation of a dish wireless monopine at 13340 Hayford Way.
 Applicants - Vicki Sisson

Vicki Sisson presented and shared a drawing. A monopine with three antennas is proposed at the corner of the Grace Point Church parking lot with enclosed cabinets to match the trash enclosure. Vicki mentioned that the Dish Wireless proposal has been discussed with the Grace Point Church and a 25-year lease is proposed.

Chair White noted that monopines do not look good and asked about additional landscaping around the monopine. Vicki responded indicating that they could take a look at landscaping opportunities.

Michelle Strauss asked about the location of the monopine and it was noted that the monopine is located near the west side of Beth Am Synagogue at the Northeast corner of Grace Pointe. Michelle asked if Beth Am was contacted and the applicant noted that they have not reached out too Beth Am. The applicant commented that it was also unknown whether the Grace Point Church had notified Beth Am about the proposal.

It was noted that there may be preference to see antennas on poles versus a monopine. Jeff Heden also suggested looking into integration with light poles and locating the pole closer to the Church building. After discussion, the applicant agreed to return to the Board after looking into the Board's concerns.

- 2. Candy Bowman: Confirm the Chair's appointment of Candy Bowman to represent the board on the San Dieguito River Park JPA CAC.
 - Applicants Frisco White, Chair

Chair White noted that Jan Fuchs has retired as a member on the CAC and Candy Bowman is available to fill the seat.

Allen motioned to support the appointment of Candy Bowman, seconded by Barry Schultz, and the motion was unanimously approved (9-0-0).

- 3. Election: Confirm the continuation of board seats for Carmel Valley Districts 1, 2, 5, CV/PHR Business, CV/PHR Property Owner, PHR D1 and D2 Representatives and Fairbanks Country Club/Via de la Valle/North City Subarea 2.

Barry Schultz motioned to confirm continuation of Board seats, second by Debby Lokanc, and the motion was unanimously approved (9-0-0).
