7. Subcommittee Report:

- a. Election Sub-Committee: Chairperson Karina handed out a list of all those who submitted Board member applications. She stated General membership applications are due before the March meeting.
- b. Priority List Sub-Committee:
 - i. Leslie Dudley submitted the following statement: At the CVCPG January 27,2020 meeting, I gave a report on the results of the Priority List Sub-Committee efforts. We had to overcome many problems: approval to form was delayed, three of the five members had serious medical emergencies, some members could not meet when rooms were available, nor visit parks or view photos to aid scouring the priority list for all eight neighborhoods. To move forward, I called a special meeting that started after a CVCPG meeting to get a quorum, we voted and approved a meeting with Councilperson Monica Montgomery and her entire staff. We had unprecedented co-operation and a good working relationship with her, and her staff who even attended our meetings. Suddenly a deadline had been moved ahead, and her staff contacted our chair and she contacted me. They needed the priority lists ASAP, they had been removed from our CVCPG website and they could not access them. I was able to supply the three lists that had been previously approved by CVCPG and the sub-committee's suggestions. Councilperson Montgomery and her staff made their final decisions and submitted their CIP List on time. We were pleased to see that they were able to use many CVCPG's recommendations for a new CIP Priority List. I had passed out the results at the January 27th meeting. I also requested that this new "CVCPG COMMUNITY FACILITIES CIP PRIORITY LIST" be attached to the CVCPG minutes, so that it cannot be deleted again from the CVCPG website. (C-Attachment).
