 Review of the Investment Policy Distribution Section for Los Penasquitos Fund – Jeff Nipp

Milliman Advisors performed a spending analysis for the Los Penasquitos Fund and presented the analysis to Parks and Recreation staff. As a result, there were no changes recommended to the spending policy of the Los Penasquitos Fund. Milliman advisors previously recommended a review of the Investment Policy.
