Action Item: Bruce Coons announced the current status of Assembly Bill 2081 involving the Old Caltrans Building. He then asked for support letters and a resolution of support for AB2081 amended to include funding for demolition of the old building and funding for State Historic Park interpretation of the site. Olive Chivers moved and Jack Borgas seconded a resolution, The Old Town San Diego Community Planning Committee recommends and supports AB2081, to acquire the old Caltrans Bldg. for the OTSD State Historic Park. Additionally we support amending the bill to include funding for building demolition and park interpretation. The resolution passed unanimously.
