Wallace N. Cooper II, AIA and Arrin Holt < www.crsa-us.com > presented a discussion of the proposed removal of the old building and construction of a new Mormon Battalion Visitor's Center. The focus of the new center will be 1) telling the story of the Mormon Battalion coming to and in S.D. and 2) proselyting. The FAR was characterized as "well within the requirements". The existing conditional use permit will need amendment. Additional activities aimed at drawing pedestrian traffic will be brick making, doll making, and panning for gold. The tree in Harney Street and a tall retaining wall were also discussed.
