**Points of Order:** Tom Doyle asked if this meeting's agenda had been posted on the premises for 72 hours. The Chairperson responded that the agenda has been posted on the Pendleton House for 72 hours, and that City Planner Michael Tudury had told her that the Pendleton House posting location was sufficient.

Alana Coons challenged the March 2008 OTSDCPG Election results. She claimed that the qualification sheets for General Members did not comply with Council Policy 600-24 regarding the qualification of "employees".

Motion: Tom Doyle moved and Fred Grand seconded a motion to refer to the City Attorney's office the question regarding the validity, eligibility to vote, of our March '08 election; and delay seating new members elect until we get an interpretation from the City Attorney's office. Motion 9Apr08#1 was approved at 3:50 pm with 10 votes for, 1 against, and 3 Members

#### **Approval of Minutes:**

Joanne Einhorn made and Fred Schwartz seconded a "Motion to approve the March 12, 2008 minutes. Motion 9Apr08#2 at 4:00 p.m. The motion was approved with 9 for, 0 against, 2 recusals, and 3 Members Elect not voting.

#### **Treasurer's Report:**

Treasurer Vicky Durham announced that the beginning March balance was \$110.22 and March donations were \$18 producing an April beginning balance of \$128.22.

**Motion:** Fred Grand moved and Joanne Einhorn seconded a **motion to donate \$135 to the Whaley House for the use of the Courtroom.** Motion 9Apr08#3 was approved at 4:05 pm with 10 votes for, 1 against, 1 recusal, and 3 Members Elect not voting.

#### **Announcements:**

Kelley Saunders, Planner is the new City Planner assigned to the Old Town San Diego Community Planning Group.

### **Action Items:**

Robert Feher presented a merchandising proposal for the Trolley Triangle on Congress Street between Wallace Street and Smith Street. <u>The Old Town Craft Merchado</u> would be run by South Sun Products. It would be a market place for working crafts people. Tents and wood temporary structures, landscaping, fencing, no parking, and no rest rooms will be provided. There was then public discussion of the concept. No action was taken.

**Proposal to Update the Community Plan:** Kevin Sullivan presented information about updating the Old Town San Diego Community Plan. Since funds for this update are not available from the City General Fund, it was proposed that North Bay Redevelopment Funding be used for the update of both the Midway Planning Area and the Old Town Planning Area. To this end 1.6 million dollars is planned for all phases of the update for both communities. This shall include hiring a consultant team to prepare a traffic study to be included in the update's EIRs. Economic/fiscal consultants will also be hired to determine the viability of recommendations. This process is expected to be a 28 month cycle. The city shall go to the North Bay PAC and request funding at their May 27th meeting.

Motion by Tom Doyle seconded by Richard Stegner that the City move forward with the update of the Old Town Community Plan. Motion 9Apr08#4 approved at 5:10 pm with 9 for, 0 against, 3 absent, and 3 Members Elect not voting.

By-laws trailed, election of officers trailed.

### **Informational Item:**

Nhon Dong, Project Engineer presented the Presidio Canyon Redirection of Flow Sewer Study with handouts. After discussion he requested that it be an action item at the May meeting.

The meeting was adjourned at 5:35 p.m.
