# Water Main Replacement Project

Project Engineer, Ms. Gehan Tadros and Project Manager Ms. Maryam Liaghat discussed Water Main Replacement Group 919. At this time there is no work planned within Old Town Community Planning Area.

The City Planning Department announced that the Planning Group, AECOM was approved by the City Council; letters have been sent to the first 7 stakeholders with no responses yet; and, that meeting could start in November. The first meeting will be to envision the goals and ground rules of the project. It is an educational phase. {This meeting has been scheduled for Tuesday November 16, 3:30 - 5:30P.M., Caltrans District 11 Office Building on Taylor Street}
