- Garrett Hager, from Councilman Kersey's office was present. He stated the budget review hearings were completed last week and on 5 /21/14 adjustments to the budget would be made. Councilman Kersey will be attending a meeting with JPA representatives, County officials, and other elected City officials to discuss funding for the San Dieguito River Valley Regional Open Space Park. Councilman Kersey is in favor of funding for this project. The city will be hiring full time staff (57 for SDPD and 16 for the pothole repair program). The SDPD will enforce neighborhood parking.
