- 10. Request for \$250,000.00 loan from Ranch Peñasquitos East Trust Fund to complete Ridgewood Neighborhood Park Tot lot upgrade, to be paid back with FBA funds in 2009. Motion to approve the request; M/S Diehl /Spurr; Approved 14-0 with 1 abstention (Politte).
