  - B. Council District One
    - 1. Stephen Heverly:
      - a. State of City Address will be January 13 at 6:00 p.m. at the Balboa Theatre
      - b. Council Committees assigned can be viewed on city website
      - c. Budget cuts and water funds are being addressed
      - d. Brown-out for fire stations is being discussed in mayor's office
      - e. There is also talk of Hazmat taking over station 46 and 47 Council has already received hundreds of emails from concerned residents
      - f. Canyon Side Recycled Water project is still moving forward
      - g. Four traffic issues are currently being looked at
    - 2. Sherri Lightner:
      - a. Dealing with the budget problem
        - i. State government has taken \$20 million from San Diego transit funds
        - ii. Supporting the Local Traffic and Tax-Payer Protection Act
        - iii. Petitions can be found on city website
      - b. No Chief of Staff since October 2009
      - c. Six graduates from the Firefighter Academy were told they don't have jobs
      - d. Working to update all water policies and create a proactive plan

- VI. PPH Community Wellness Campus (Information Item):
  - A. Was original a IL-3-1 and now is a CC-3-1
  - B. They have a Neighborhood Use Permit due to the urgent care portion of the facility
  - C. Other than that, the project is exactly the same; all conditions are the same
  - D. Sandstrom asked about the significance of the new zone. A: It is the least intensive of the community/commercial zones
  - E. Q: Regarding equipment seen on the site. A: Does not belong to the developer

  - G. Q: Would the new zoning allow for a church if the current project was not built? A: Yes, with a CUP

  - 3. There can and will be reclaimed water used on Camino Del Sur from the 56 to Carmel Valley Rd. if and when the shopping center adjacent to Westview High agrees
  - 4. Christmas tree lot on Camino Del Sur had an electrical permit (seems that is all that is required because it is seasonal)
