Public Comment on Non-Agenda Items:

William Perno. **Alcohol and Drug Prevention Specialist**. Speaking against the proposed ordinance that would remove current local cannabis retail sale restrictions. The safeguards allowed under Proposition 64 have been enacted with best practices buffer zones throughout the city. The concern is that there has been no meaningful input from the community.

David Ege, San Carlos Library. The book sales are back the first Saturday of each month. The work is coming to completion on the next-door lot as the next step in purchasing the property.

Fiscal Year 2023 Council Budget Priorities Resolution

San Carlos Library: Well destruction is complete, awaiting no further action letter to be able to route the purchase sale agreement to the Council

Allied Gardens: bike lane road markings were restriped on Mission Gorge Rd, streetlights were repaired on Greenbrier Ave, and an illegal makeshift stop sign on Greenbrier Ave was removed by City staff

Grantville: Next week Councilmember Campillo will join the Mayor, MTS, and Affirmed Housing for the groundbreaking of the ShoreLINE Apartments at the Grantville Trolley Station

Councilmember Campillo issued a memo to the Independent Budget Analyst containing his budget priorities for the upcoming fiscal year. Some Citywide highlights include small business and non-profit assistance, youth internships and employment opportunities, staffing for Parks & Rec, infrastructure improvements in the right-of way, funding for SDPD storefronts to improve response times,

homelessness and housing. Local Navajo highlights include the San Carlos Library, Alvarado Canyon Rd Realignment, and Allied Gardens Community Park.

Chair, David Smith. None

Vice Chair/CPC Representative, Brian Giles. The Community Planning Council (CPC) had another meeting at which Councilmember LaCava spoke. The CPC sent a long list of items that need to be changed. The vote will be pushed back while the proponents of the proposal "red line" the changes. He was receptive of certain items, but until the changes in the proposal are made we can't comment. When it comes back with the "red line" to the CPC will have one more chance for comment before it goes before the Land Use Committee of the City Council, tentative in March 2022.

Tamar Caspi. Comments that this is being pushed through very fast. Why is it going so fast? Shain Haug. Concurs that there is no reason for this moving as a rush job.

Brian Gile. Comments that the CPC has been working on this diligently, has many comments and suggestions. The Councilmember has simply said he is working on it. But until the "red line" version is on the street we really cannot make specific comments.

Tamar Caspi. Comments that we may have to call a special meeting. Comments that the San Carlos letter may be moot. Brian Gile responds that until we have the "red line" we do not have anything specific for comments.

Marilyn Reed. Asks whether the CPC took a vote on the specific comments. Brian Gile advises that a subcommittee prepared a list of issues that represented the consensus from the CPS that were presented to the Councilmember by CPC.

John Hoy. Comments that we should not count of the Councilmember to be fully responsive to our concerns. That we should not assume that he will make the suggested changes. We should be forthright with our issues in our expression of concerns with the proposal as it stands.

Brian Giles. Suggests we approve the proposed draft letter with attachment of the CPC list of issues and recommendations rather than draft another letter, a notation of agreement with CPC. Agrees that the communication

Discussion Items:

Navajo DIF account: 2021 Deposit and YTD Total. The Development Impact Fund explained by Cory LaShell as income from development for capital improvements in the districts. The recent allotment is attached as Exhibit "B." NCPI has \$7m in reserve. The Projects List is attached as Exhibit "C." The Build Better SD City of San Diego proposal is for a pooling of the DIF for the benefit of areas that are less well off because of development issues rather than using exclusively in the district. This would be a more efficient way to use the money and to avoid uses just to avoid time limitations. This could benefit lower socio-economic neighborhoods. Lance Gruela asks for an update after the CPC meets and discusses this issue.

Navajo and Park Ridge traffic safety concerns, Tina Fransson. Not in attendance. Tamar Caspi comments that she probably would have discussed the same issues mentioned to the Councilmember's office.

UT Community Reporter, **Emily Alvarenga**. She is working to develop neighborhood coverage and to solicit information of concern to the communities.

Exhibit "A"

There is a tension between the vested authority found in Charter Section 43(b) and the foundation of community service memorialized in Council Policy 600-24. The former is the basis of the authoritarian structure of the planning process. The latter recognizes that government arises from response to the needs of the communities served. The tension is most apparent in the obligation of the Planning Department to give consideration to the recommendations of the Community Planning Groups.

The questions raised by the Grand Jury report were those of participation, governance, and transparency of Community Planning Groups that weakened the oversight by recommendation of the Groups. The proposal for change to Council Policy 600-24 suggests changes that will address these questions. These matters that are in negotiation between the drafters and the Community Planning Council. For the time being, before we join in the discussion of specific provisions, we leave those matters to the negotiators.

But the proposal goes beyond issues of organization. It addresses the fundamental purposes of the Community Planning Groups. Rather than provide for a stronger voice in land use and development the proposal takes quarrel with the relevance of Groups. It treats the tension between Planning Department and the Groups not as a healthy, on-going interaction but as conflict that must be resolved by diminishing the posture of the Groups as protectors of their neighborhoods.

Developers and planners, planners in particular, recoil from recommendations that are contrary to their concept of the project; they object to delay that may be necessary to consider suggestions and objections of the Community Planning Group. But the former objection ignores the rights of those who share their communities with the developments. The resolution of the latter issue is not found in the restriction of the role of the Community Planning Group. Rather, the answer is found in the expansion of that role: in bringing the Group closer to the planners, in increasing the scope of and number of projects subject to review, and in bringing the Group earlier into the process.

The Community Planning Groups as they now exist have been around for a long time. This connection between the Groups and the City has demonstrated the viability of the relationship and has established a precedent that Council Policy 600-24 conforms to the requirements of the Charter. The issue of conflict with Charter Section 43(b) is a red herring, a false flag, that must not be a basis to make it harder for the citizens to speak to their elected officials.

In addition, the Navajo Community Planning Group takes this opportunity to register its endorsement of the positions earlier taken on this matter by the Community Planning Council and the San Carlos Area Council in its letter of January 24, 2022.
