• Key Transportation facilities: Coronado, Point Loma, and San Diego,

- Key Objectives: Enhance ongoing efforts, develop climate resiliency strategies, and provide data sharing.
- Adaptation strategies ensure critical transportation facilities and key access points are not impacted by climate threats.

Emily Bonner- advised emergency ordinance for fee relief is police regulated for Business Occupancy. Timeframe of three months [31Mar2021-28Feb2022
