Update from elected official representatives on possibility of incorporating improvements into approved Mobility project per community and board inputs at Nov 2020 NPPC board meeting

- Lack of shaded trees on the new median per city's climate action plan
- Removal of flashing beacons on planned crosswalk
- Sidewalk improvement and additional lighting (historic design lamps)
- Lack of bike rack additions along the avenue

Presenters and PFT Subcommittee discussion

- Ryan Darsey
  - Three new flashing beacon style crosswalks plus enhancing Alabama crosswalk
  - Pershing crosswalk will be removed since median will be installed
  - Evaluations must be done by San Diego Bike Program to install bike racks in public right of way. NPPC can request evaluation by San Diego Bike Program.

- Kohta Zaiser
  - Trees need irrigation. Concern is tree roots could create water leaks in irrigation that could shut down University Ave. For this reason, large trees will not be installed in the median.
  - Historic decorative lights can be added if funding provided from another source. The project does not have the budget.
- Matt will check with North Park MAD to see if there is a possibility to fund cost difference for historic decorative lights. Last month, MAD just approved budget for upcoming year.
- Need to understand cost difference of historic decorative lights. Cobra lights are currently in the project now. Kohta will research cost difference.
- North Park Mini Park is currently installing the historic decorative lights. Can get cost from project manager.
- Regarding trees, Kohta was informed that there is an existing sewer line the runs directly below median. This also is a reason for not having trees in median.
- Kohta will get more detailed information on why trees cannot be added to median.
