The project consists of two (2) legal lots, located south of the Mt. Albertine Avenue and Salizar Street intersection. The application is proposing to subdivide the two Lots into 13 legal lots for the development of 13, 2-story single family homes that will range between 2,000 and 2,200 square feet.
