- b. SDG&E's 50-year franchise agreement contract is coming up for renewal with the City in a year. They currently collect from ratepayers a total of 6% that goes to the City for things like undergrounding utilities. 1.5% is more typical of other deals, and competitors might go that direction. Term of agreement and everything else up for discussion. Look for more in the news. (Moriah mentioned there are workshops from 2/18-19.
