A. <u>City of San Diego AT&T new wireless site- Project No. 672332 – Becky Todd, MD7</u>

The project proposal is for a new concealed/stealth wireless facility. The structure type proposed is for a tower/cupola design, 55 feet in height, with all equipment fully enclosed within the structure. There will be 12 antennas and associated cabling and radio units in the upper cupola portion, with cabinets, utility connections/meters and a backup power generator installed within the structure at ground level. The exterior finishes for the new structure will pick up the terra-cotta style roofing and sand-colored paint that is used in the existing and adjacent buildings. The project will be located in the back parking lot of an existing automotive relate business at 8359 Otay Mesa Road.

- B. <u>City of San Diego CIP Palm Ave I-8o5 Interchange Project No. S00869 Stuart Osborne, City of San Diego</u>
 The City of San Diego Capital Improvement project, Palm Ave I-805 Interchange Project (S00869), which is currently entering our 100% design phase. This project is both a City of San Diego and Caltrans undertaking and consists of civil improvements such as the bridge widening of the Palm Ave overcrossing, reconstruction of the on and off ramps at the interchange, sidewalks, bikeways, traffic signals, striping, new curb ramps, a multi-use treatment area for runoff water, and roadway improvement.
