- -Comment to Staff Representative about a utility access plate on Mission Village Drive which was lower than street level as a possible danger to bicyclists, open hole on Aero Drive, and rough pavement on Sandrock Road

# Mazzika Hookah Lounge On-Site Beer License Application at 8690 Aero Drive-

Presentation by Dr. Sam Jihad. Bob McDowell made a motion to recommend approving the license. Nick Romero seconded. Vote: 7-3-0 with Denise Davidson, Mark Perry and Cindy Moore voting against. The main opposition argument was that food was not being served with the alcohol.

**Top Three Serra Mesa Neighborhood Issues**-After discussion, it was determined that the list of top issues should contain four items (listed in no particular order):

- -Completion of the Ruffin Canyon Trail
- -Upgrading of Fire Station 28 on Kearny Villa Road
- -Birdland Traffic Issues
- -Undeveloped Lots in Serra Mesa (all privately owned)

Bob McDowell made a motion to approve this list. Denise Davidson seconded. Vote: 10-0-0

Review Draft Environmental Impact Report (EIR) Stadium Reconstruction Project-General discussion with the consensus that it appears that the stadium is being replaced

with the assumption that conditions surrounding the stadium have not changed, meaning that very little mitigation is necessary. It also appears that, although further development in the area may be considered at a future date, any further development would be considered as separate from possible stadium reconstruction. The main concern of the Serra Mesa Planning Group was that, although Serra Mesa is near the stadium site and is affected by stadium traffic and noise, the EIR seemed to ignore any impacts to the Serra Mesa community. While no action was taken by the Serra Mesa Planning Group, it was decided that Cindy Moore would write a draft letter with comments for review and approval at the September 17<sup>th</sup> SMPG meeting.

**Review Climate Action Plan Draft EIR**-General discussion that the draft appears to be much more of a plan than the previous draft considered by the Serra Mesa Planning Group. However, it appears that this version does not consider growth in the city which would essentially negate any savings under this draft. While no action was taken by the Serra Mesa Planning Group, it was decided that Bob Crider would write a draft letter with comments for review and approval at the September 17<sup>th</sup> SMPG meeting.
