7:06 p.m. Announcements & Non-agenda Public Comment.

1. Member recommended drafting a letter thanking the city for their excellent communication with the community regarding updates on the Otay 2nd Pipeline..

3. Member commented on a San Francisco Tribune article from 1994 stating affordable housing in San Francisco is a beacon.

7:16 p.m. Reports

1. San Diego Police Officer Vicki Coore discussed Coffee With a Cop July 11. Crime stats & prevention measures handout passed out. Community members asked about an increase in graffiti, whether there was an actual increase in crime in the neighborhood and if it was gang related, package thieves, late night presence of strangers at doors, homeless encampments at Briarwood, police response to active break-ins, and sidewalk tribute clean-ups.
2. Representatives for City, County, and State.
 - a. Representative for Councilmember Monica Montgomery, E. Henson:
 - i. Townhall for transitional storage facility in District 9, near the northern edge of District 4. No known plans for one in District 4 at this time, but there are safe parking lots.
 - ii. Mochas with Monica July 12.
 - iii. July 24 Public Safety meeting, live streamed on CityTV and available on library computers. Public input desired.
 - iv. Inclusionary Housing meeting discussing the reformation of current policy allowing developers to pay a fee to build the 10% affordable housing elsewhere.
 - v. Planning Department will be meeting to discuss error in zoning at Lisbon and 69th affecting one house in a commercial overlay zone.
 - vi. MTS meeting 10 a.m. July 11. Public input desired.
 - vii. SANDAG meeting July 12. Discussion of whether military housing should be included when calculating affordable housing totals for an area.
 - viii. Community questions:
 - Q: The recent list of approved sidewalk additions in District 4 did not include any sidewalks in Paradise Hills. When will they be?
 - A: Still working the issue.
 - Q: GetItDone has been used repeatedly for weed abatement blocking sidewalks on Paradise Valley Road and Alsacia Street near schools as fire Hazards. No response.
 - A: Will work with city or private office to follow up.
 - b. Representative for Rep. Susan Davis:
 - i. House passed Defense Bill this month including Rep's ammendments to improve childcare, mental health services, and sexual assault victims' rights and Protections.
 - ii. Stop Summer Child Hunger Act reintroduced, allowing EBT benefit card to be used during the summer.
 - iii. Cosponsored Green New Deal.
 - iv. Healthcare Roundtable addressing impact of attacks on the ACA with local healthcare workers.
 - v. Global Speaker Series on Climate Change brought out a few hundred

community members. Facebook Live has a video of the event.

vi. Military initiatives are not yet available online as they have not been passed in the whole house.

- c. Representative for Assemblymember Dr. Shirley Davis:
 - i. Apprenticeship Expo.
 - ii. 2020 Census meeting July 20.
 - iii. Sponsored AB392 impacting communities of people of color,, interactions with police departments.

- 3. G. Preuss summarized recent CPC actions.
 - a. City of San Diego contracting procedures.
 - b. Planning update by Circulate San Diego wanting CPCs to be more diverse, with seats reserved for renters, business owners, etc.
 - c. Assembly bill SB50/330 merged into SB592. Language of SB592 was gutted and language from SBs 50 and 330 was added. CPC opposes all three.
