- Working with Parks & Rec department to extend the time dogs are allowed on Mission Bay
- New Short Term rental rules go into effect May 1st. Any violations will be able to be reported on the Get It Done app.
- Suspects apprehended for the shooting that occurred Feb 19th at North Clairemont Park
- Many complaints about the Purewater construction on Genesee Ave.

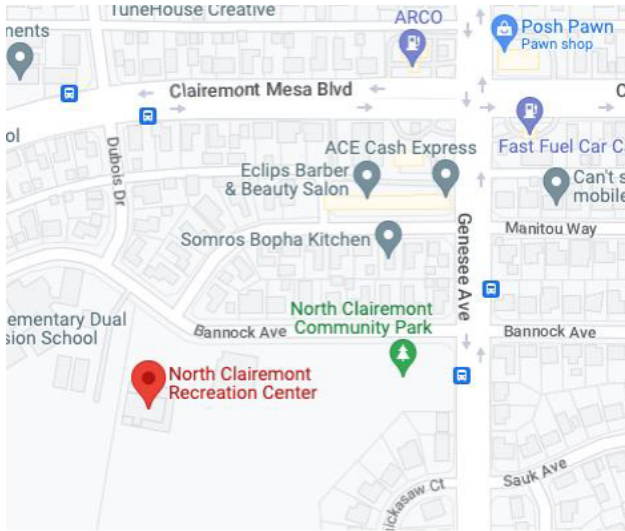
- **901: SANDAG Rapid Bus Route 41**
 - Brian Lane Brian.Lane@sandag.org from SANDAG presented
 - Several Rapid Routes are already in operation in San Diego County
 - Rapid Routes are designed to have fewer bus stops in order to allow buses to cover greater distances faster. Most stops are approximately 0.5 miles apart
 - Rapid Routes may have access to dedicated bus lanes and improved traffic signal coordination
 - Rapid Route 41 is expected to run along the Genesee corridor between the UCSD campus and Fashion Valley mall, possibly extending to the UCSD Medical Center in Hillcrest; will be the first Rapid Route to run entirely within San Diego city limits
 - Funding currently is only available for route planning. Construction funding from Federal and State sources is anticipated
 - Various streetscapes of bus lanes were presented, along with bicycle and pedestrian throughways
 - Detailed maps proposed bus lane layouts were presented
 - Fares may be collected before boarding bus to avoid delays
 - Construction expected to start in 2 to 5 years, depending on funding
 - A survey to receive public opinion is available at <https://www.surveymonkey.com/r/W5PFNTB>
 - Questions included:
 - Direction of travel for bikes in bike lanes
 - Bike lane access across SR52
 - Heavy traffic along Genesee near University City High School
 - Loss of traffic lanes along Genesee, particularly during construction
 - Support was given to extending route to UCSD Medical Center in Hillcrest
 - Bus types will be the articulated busses (i.e. the long 2-section bus type)
 - Rapid Route 41 will not replace the current MTS Route 41. Both routes will operate concurrently.
 - Rapid Route is expected to run until midnight 7 days a week
 - Landscaping will be included when medians are affected. Landscaping will be supervised by the City of San Diego
