Fiscal Year 2025 Proposed Budget

- Mayor Gloria recently released the proposed budget last week. The Fiscal Year 2025 Proposed Budget represents an increase of \$473 million, or 9.1 percent, compared to the Fiscal Year 2024 Adopted budget. This is primarily due to increases in the Special Revenue Funds, Capital Improvements Program, Enterprise Funds, and General Funds.
- Starting in May, each department will present their budget to the full Council. The Council will then make any changes they deem appropriate and necessary. The Council has to make a final decision regarding the approval or non-approval of the budget in June.
- The public will have several opportunities to participate and provide input as we progress with the budget. We will be sure to send out the dates/times for the meetings where the public can provide input.
