4. Homes at end of Carmel Mountain Road moved from Parkview (District 10) to Peñasquitos Creek (District 11).

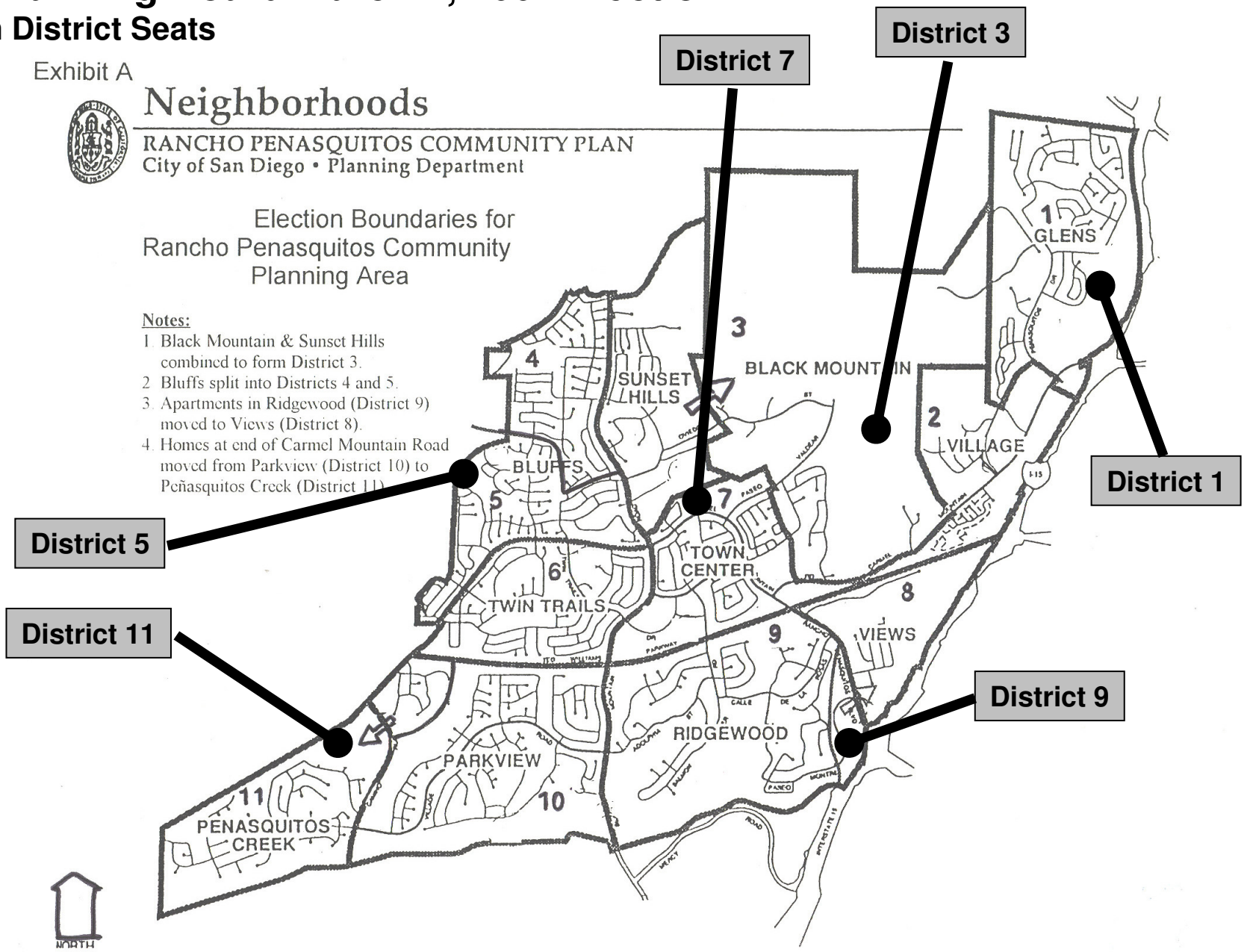
