- **b.** San Diego Wastewater Department: Update of the City of San Diego Wastewater Department Renewable Energy Projects to be installed at the Southbay Water Treatment Plant. Mr. Tom Alspaugh presented. The stack for the fuel cell project will be fenced and surrounded by palm trees. The stack will be lower than the building next to it. M. Freedman would like the Wastewater Department to spend more time on the aesthetics of the fencing. Hire a landscape consultant to have fencing blend with surrounding environment. It was also suggested that the stack be painted, and maybe a different type of fence. **Item Continued.**
- c. <u>San Diego County Treasurer-Tax Collector</u>: Mr. Dan McAllister presented information regarding property taxes and other work from his office. No Action Required.
- d. El Pedregal Family Apartments: Update of 45 unit affordable housing project located at 104 Averil Road. The Agency entered into an Owner Participation Agreement (OPA) in July 2007 and will now consider terminating the OPA and entering into a Disposition and Development Agreement (DDA) for the same project. Agency funding for the project is unchanged at \$3,606,000. Xavier Del Valle, Project Manager and Sam Johnson, Assistant Project Manager of the San Diego Redevelopment Agency presented. The owner of the land for this project has chosen not to participate, so now development wants a DDA. A DDA would allow for eminent domain. Motion by M. Freeman and Second by T. Currie to recommend that the Agency terminate the OPA. Motion passed: 10-0-0.
- e. <u>Verbena Affordable Apartment Project</u>: First Implementation Agreement to the Owner Participation Agreement (OPA) for the Verbena Affordable Apartment Project. The project is an 80 unit affordable housing project located at 3774 Beyer Blvd. The Agency entered into an OPA in July 2007 and will consider adding an additional \$454,000 in San Ysidro 20% set aside funds. Xavier Del Valle, Project Manager and Sam Johnson, Assistant Project Manager of the San Diego Redevelopment Agency presented. Project did not secure the 9% tax credits. To score better developer will try to secure 4% tax credits. To help in securing the 4% tax credits, 9 units must be set aside for mental health service programs, people with mental disabilities. Item Continued to March to research term "mental disabilities" and check with SY School District as project is close to schools. **Item Continued.**
- **Calle Primera Residential Development:** Prospective Residential project at Calle Primera APN 666-140-07 on a 2.75 acre site. Mr. Joseph Garcia property owner and Mr. Mike Stevens of Stevens Planning Group presented project. Property is now zoned RM-1-1. The property owner is considering two plans: one with 40 units and second with bonus units. The Planning Group would like to see schematic designs before offering suggestions. **NO ACTION TAKEN.**
- g. <u>International Trade Center</u>: Applicant requests renewals of January 19, 1993 vote on supported motion regarding APN 666-010-40. Applicant stating mapping error exists. Applicant interested in participating in timing/role of the San Ysidro Mobility Strategy and planning and implementation of Calle Primera linkage to Camino de la Plaza. Mr. Joseph Garcia property owner and Mr. Mike Stevens of Stevens Planning Group presented project. **Motion by D. Flores and seconded by I. Adato to support the initiation of a Community**

Plan Amendment and rezone of a portion of APN 665-010-40 to SYIO-1-1. Motion Passed 10-0-0.


