- 7. Officer Carlos Lacarra (SDPD): There has been an increase in phone scams, using scare tactics stating owning the IRS or fines or have a warrant.
- 8. Officer Carlos Lacarra (SDPD): If you don't want solicitors at you home post a "No Soliciting" sign. By law with a sign they can't solicit. Ask for a City Business Certificate if any doubts.
- 9. Officer Carlos Lacarra (SDPD): 1 medical marijuana dispensary has been approved in Otay Mesa on Roll Dr. 3 more can be allowed in District 8. Medical marijuana dispensaries are allowed to exist and SDPD will do all to ensure they abide by the law.
- 10. Officer Carlos Lacarra (SDPD): San Ysidro High School has recently received several bomb threats. Internet Crimes Against Children is investigating as calls were computer generated.
- 11. Officer Carlos Lacarra (SDPD): Institute for Public Strategies send out decoys in December 2014 to 10 south bay Liquor Stores. 9 out of the 10 did ask for identification. A letter was then sent to store owners detailing results.

5. Docket Items:

- a. Pacifica Ridge SDP/TM (Aaron Parker Applicant). Withdrawn by Applicant.
- **b.** 2345 Via Segundo MMCC CUP (Bradley Sonnenberg, Applicant) Conditional Use Permit to allow the operation of a Medical Marijuana Consumer Cooperative (MMCC) in an existing 1,924 sf commercial retail suite. The 0.63 acres (27,443 sf) site is located in the SYIO I-1 zone in the San Ysidro Planned District and in the Coastal Non-Appealable Overlay Zone. Applicant would purchase building and paint, remove illegal signs and fix parking lot. No cultivating of marijuana on site and all product is tracked. Security would be added. Patients are only allowed to purchase what is prescribed by a physician.

Patients are only allowed into building once a prescription has been approved. Public Comments were made concerning the proximity to Willow Elementary School, residential development, families with children and the Border; non-compatible businesses and area being a retail area; security issues such as re-sale of product and smoking in parking lot; "what is the benefit to the community?"; sales of candy and baked goods with marijuana, thus targeting children; and traffic congestion. A motion was made by B. Gonzalez and seconded by A. Martinez to recommend against approval of the 2345 Via Segundo MMCC due to concerns about traffic congestion, proximately to residential development, incompatibility to existing retail commercial uses. Motion Passed (10-1-0) Yes: M. Aguirre, M. Chavarin, L. Corrales, D. Flores, B. Gonzalez, J. Goudeau, A. Martinez, B. Meza, R. Moran, S. Otto. No: M. Freedman. Abstain/Recuse: None.

- c. San Ysidro Community Park Playground. (David Flores, Casa Familiar) D. Flores recused himself from the SYCPG Board for this item. Request a letter of support for a \$561,000 grant from City of San Diego Community Development Block Grant. The project has received grant funds from Wells Fargo Bank and the County of San Diego, to be used for the reconstruction and ADA upgrades of the "tot lot" and surrounding path of travel at the San Ysidro Community Park. Project will be submitted next month for the building permit and demo of the existing playground should begin soon and continue until June. Project should be completed in December 2016. There will be a meeting on Thursday 1/29/15 at Casa Familiar Civic Center to decide on play equipment. Goal is to bring park up to ADA code and make a more pleasant place. A motion was made by A. Martinez and seconded by R. Moran approve a letter of support for CDBG Grant funds. Motion Passed (9-0-1) Yes: M. Aguirre, M. Chavarin, M. Freedman B. Gonzalez, J. Goudeau, A. Martinez, B. Meza, R.
