IV. Information and Action Items

• Huntington Avenue Storm Drain, Action Item. Presenter: Jason Guise, City of San Diego.

Description: Application for Site Development Permit (Process CIP-2) (ESL, MHPA) for replacement of approximately 300 linear feet of 24" Corrugated Metal Pipe (CMP) with a new 24" Reinforced Concrete Pipe (RCP) in place. New cleanouts will be installed at the connection point and end of the downstream drain. Project is located in an easement from Huntington Avenue and Wilbee Court into the canyon (RS-1-4 and OC-1-1 zones). Decision will be made by Development Services Department Staff.

• Neighborhood Use Permit/Neighborhood Development Permit/319086 – Sprint SDGE Tower, Action Item. Presenter: Kevin Moe, Agent Representing Sprint.

Description: Application for a Neighborhood Use Permit/ Neighborhood Development Permit, Process 2 for a Wireless Communication Facility consisting of 6 panel antennas and 6 Remote Radio Heads attached to an SDGE transmission pole located south of Phyllis Place, just west of the I-805 south on-ramp. Associated equipment is in an existing 334-square foot enclosure. Modifications to the equipment within the enclosure are proposed with this project. The original permit approving this project expired 3/21/12. Decision will be made by Development Services Department Staff.

• Verizon Murray Ridge, Action Item. Presenter: Morgan Chee, M&M Telecom, Inc.

Description: Application for a Process 3 Conditional Use Permit and Neighborhood Development Permit for a wireless communication facility consisting of a 30-foot tall architectural tower concealing 12 panel antennas, 18 remote radio units and a 2-foot diameter microwave dish. Associated equipment will be located in the base of the tower and an emergency generator will be located in a proposed 144-square foot block enclosure. A 264-square foot storage unit for the church is proposed adjacent to the generator. The facility is located at 2285 Murray Ridge Road in the parking lot of the Faith Community Church in the RS-1-7 zone.
