SAN YSIDRO GRAND CENTRAL SUMMARY BENEFITS

San Ysidro Planning Group Monday, July 18, 2011

A new San Ysidro ITC should be a multi-functional, transportation hub that serves our binational communities and also stimulates respective economic revitalization. The project should also celebrate the historic, dynamic and an evolving relationship between our two sister cities, as well as serve as a National Gateway symbol

Only a mixed-use, destination-oriented, "Grand Central" concept can achieve this. In order to spark international commerce and enhance various modes of mobility the project must offer a "sense of arrival" and travel purpose. Touristic themes must also pay a vital role in the establishment of a true Landmark project.

Synergistic elements in a mixed-use development will catalyze a powerful magnet effect to the border, and provide spring-board opportunities for both countries. These are just some brief highlights of what could be possible with a highest and best use design on the 700 Block of E. San Ysidro Boulevard:

1. Iconic San Ysidro Community Elevated Trolley Terminal Platform

- Trolley travel path is elevated above grade eliminating vehicle/pedestrian conflicts;
- Trolley Terminal Station is reestablished more accessible to SY business district by relocating approximately 300' to intersection of Camino de La Plaza and E. San Ysidro Blvd.;
- Trolley riders are transported even closer to the border than present via people-movers through a pleasant experience and commercial project with amenities.
- San Ysidro business districts benefits from better access to/from Trolley.
- Iconic elevated Trolley Terminal Platform is distinguished as a San Ysidro partnership with MTS and City of San Diego.

2. Streets and sidewalks are widened due to recapture of Trolley rights of way

- Wider streets and sidewalks will facilitate higher volumes of traffic projected from area growth and more efficient new border crossing facilities.

3. Tax Increment Revenues

4. Smoother Pedestrian-Vehicle-Trolley Traffic Flow

- Vehicle, Pedestrian as well as Trolley continues on respective paths of travel uninterrupted by trolley conflicts at grade level.

5. Public Transportation

- Centralization of "ALL" modes of modes of public & private transportation eliminates confusion with travelers seeking legitimate transportation services;
- New transportation hubs and modes are established: Community, Cross-Border shuttles, i.e. medical, airport, other special purpose destinations.
- Illegal Wild Cat transportation activities are greatly reduced.

6. Public Safety

- Innumerable security systems, i.e. private/public patrol, camera surveillance and monitoring, directional signage and organizational economies of scale measures can be implemented to safeguard the public.
- Homeland Security utilization of project's magnitude and tower elements.

7. Public Parking

- Loss of 1250 parking spaces, or over 50% of San Ysidro's public parking, is restored to the community.

8. Enhancement of Pedestrian Mobility on Border

- Large scale parking structures provides vehicle storage services to border-crossers from both countries choosing to walk across the border, thereby enhancing non-motorized mobility on the border.
- Walking is encouraged through pedestrian friendly infrastructure; health is improved.
- Security benefits in easier detection of pedestrian vs. vehicle smuggling/concealment.

9. Iconic Landmark

- Global platform for the City of San Diego & Tijuana.

10. A Welcoming Grand Plaza National Gateway

- A worthy, world-class public plaza in place of the present MTS bus turn-around in front of U.S. Customs Exit.

San Diego-Tijuana Existing / Planned New Border Crossings:

Existing

- 1. San Ysidro-Puerta Mexico. Currently under \$600M construction, largest POE expansion in U.S. History;
- 2. Otay Mesa-Mesa de Otay. \$21.3M awarded for reconfiguration and moderanization;

Planned

- 3. Otay Mesa East II-Mesa de Otay II. Toll Crossing for commercial vehicles and new state route 11, construction start 2013, completion 2015.
- 4. San Diego-Tijuana Cross Border Facility (Tijuana Int'l Airport). Will develop private facilities for Airline Ticket Terminal and incorporate above grade pedestrian toll bridge between 52 acre Otay Mesa project and Tijuana's Int'l Airport.
- 5. San Ysidro expansion project, Phase III, Virginia Avenue. North/Southbound Pedestrian Only Border-Crossing Facility.

Population projections by 2050: San Diego, 4.5M; Tijuana 5.0M

San Ysidro-Puerta Mexico POE is a MEGA TRANSPORTATION HUB. Many transit components going on; problem is that they are all scattered about-see figure map. Need to centralize/organize.

- Mobility on border must be handled in a "Security Context"
- U.S. needs to understand what is happening south of the border
- Role of private sector must support role of public functions

CBP speaker: San Ysidro Port of Entry a mess! Will continue a mess for some time. Closing 8 lanes (17-24) in November; will double-stack lanes 3-16.

Otay Mesa BRT (Bus Rapid Transit) will commence 2014, not 2020.

Prior to September 11, 2001, 1-3% of all northbound border-crossers were name queried at inspection; today, 100% are queried. Has led to increased felony arrests and exportation to their respective jurisdictions and countries.

New SY SENTRI office (former Payless Shoes, 795 E. SY Bl.), handling 88 applications/day; had projected 25 apps/day. SENTRI office will become interim Northbound Pedestrian Processing Facility during Phase II demolition of existing pedestrian building and then build new pedestrian northbound facility.

Ready lanes are 25% faster than regular lanes. RFID chip documents, APIS, (Advanced Passenger Information System), prescreened card holders, Global Entry Qualified systems will continue to evolve in border use by CBP. Systems will be accepted in all world port entries.

Jennifer Williamson, SANDAG Senior Planner & Stephen Vance, SANDAG Senior Planner:

PROPOSED SAN YSIDRO ITC:

- SANDAG has pledged \$50M (in 2010 dollars) towards SYITC.
- SANDAG/MTS does not want to relocate trolley further away from border, closer to San Ysidro business community.
- Pending City RFP will study analyze grade separation (elevated platform) of trolley,
 commercial uses and public parking.
- Caltrans planner (unofficially) shared that MTS has budgeted \$100M for SY Trolley Terminal improvements, likely involving grade separation and shifting of tracks to east.
- ITC building footprint size of 3.5 acres proposed, incorporating areas of 700 Block of E. San Ysidro Blvd:
 - o McDonald's Trolley Station, 727
 - o Baja Duty Free & its parking lot, 723
 - o International Bldg, 751 & International Market, 747
 - MTS Bus turn-around

Otay Mesa Border Crossing: U.S. Government will acquire private property at Nicola Tesla Court, 1.5 acres, for construction of southbound pedestrian plaza.

Bicycle Network: New programs in Tijuana for Bike Stations, bike sharing/membership. Mexico City has Bike Program with 30,000 members.

Directions of travel – people tend to use most direct route. Planners don't always design according to needs of actual users, i.e. worn paths over landscaped areas, through properties, bicycles prohibited on Ped Bridge (signs posted) and pedestrians use SY southbound Bike Path.

Rodolfo Argote, Tijuana Metro Planning Institute: SANDAG is sponsoring their Strategic Planning in constructing vision for City of Tijuana. Will address high volume bus lines and binational mobility. There are many cyclists in Tijuana but we are missing infrastructure and sidewalks.

Tijuana Mass Transit. SANDAG working with Tijuana Transportation Plan. Commencing at San Ysidro border, Tijuana will develop Bus Rapid Transit (BRT) systems/corridors throughout Tijuana to Rosarito and Tecate to serve population explosion growth. An efficient Tijuana Mass Transit will increase pedestrian border traffic by a minimum of 20%

Richard Gomez, Inter-City & International Bus Industry: Bus is the most cost effective mode of transportation. Aging baby boomers are relying more on bus systems. San Ysidro processed more than 1.5 million U.S. northbound bus passengers in 2010 and 1.8 million Tijuana to San Ysidro Border bus passengers from Tijuana Airport and other terminals. Challenges & Opportunities: A San Ysidro ITC that serves ALL modes of public/private transportation. Public Planners must work with actual operators and users of facilities to design proposed projects. Bus companies must be an integral part of the overall planning process.

City of San Diego, Samir Hajjiri-senior engineer & Teresa Millete, Otay Mesa Planner: A Grand San Ysidro ITC can serve as an international commerce hub. An iconic center can integrate all

modes of transport, supported by commercial and public parking. We cannot continue to fund band-aid projects that don't properly address long-term solutions. Planning must be conducted in a border security context.

Andy Hamilton, President, Walk San Diego: Tijuana is an opportunity for affordable housing for San Diego workers. There are numerous benefits to enhancing non-motorized mobility on border: Harder to hide weapons and other illegal contraband; reduces smog/gashouse emissions-a growing issue; increases health of border-crosser. However, non-motorized infrastructure must get the DESIGN RIGHT! We cannot increase walking distances by poor planning. Andy: "Let's eminent domain parking lots and warehouses to properly plan/design projects."

Stephan Vance, Senior Planner, SANDAG: Difficult to plan in competing silos of interest. Air quality is major issue. We need to move vehicles through faster.

Chris Schmidt, Caltrans: Many overlapping circulation issues; undersized walkways. Bicycles: Incentive to use 100 space bike racks at 700 block was taken away by Customs. Friendship Plaza will be lost with Port expansion. There are Interregional T dollars available. If there is a unified vision, funding will be made available. Friendship Plaza can be reinstated through ITC project or on West side.

Sharon Cooney, MTS, Director of Government Affairs & Community Relations: We need to create a "Sense of Urgency"!

Fausto Armenta, Tijuana Municipal Planner: San Diego-Tijuana is auto oriented. There are many cyclists in both cities. The Mass Transit mobility potential in Tijuana is great-but to what avail if people are camped at the border. Users live and breathe issues. In Mexico, bus is the preferred mode of travel.

General observations:

- Very interesting forum.
- Strong theme of a San Ysidro ITC's binantional importance ran throughout afternoon.
- Lots of binational brass in attendance-see program.
- There is no clear leadership.
- Many of general attendees/audience expressed frustration with public planning process and public planning's distant attitude with "Non-Planning Sector". In other words, what do we know?
- Frustrations extended to lack of Federal support and engagement from both countries.
- There was a sense of urgency among speakers/audience.
- Pending City ITC RFP is an excellent opportunity to integrate planning workshops involving users, private sector, community stakeholders and Feds.
