

## SAN YSIDRO COMMUNITY PLANNING GROUP Infrastructure & Public Improvements Subcommittee

#### Notes from Meeting April 16, 2012

- 1. Attendance: Antonio Martinez, Matthew Paredes, and Steve Otto; Melina Meza (Council District 8), Clarissa Falcon (Las Americas), Jennifer Goudeau, Jason Wells, and Andres Ripa.
- 2. Review and update status recommended public improvements at 190 remaining locations, not implemented from previous "rounds" (vetted by SYCPG):

#### 2008:

- \* New sidewalks north side & street widening at/near 4570 Camino de la Plaza, about 600 LF—Understood that minimum \$300,000 committed from previously encumbered redevelopment funds
- Nineteen roadway improvements adopted by SYTC (includes SYCPG), and forwarded to Mayor Sanders—Understood that these roadway improvement proposals have been incorporated for study as part current SYCPU process

#### 2009: 95 locations:

- \* Four new traffic signals (SYB-each at Averil, Alverson, and Center St. & Beyer/Smythe Crossing)
- Three remaining street repaying segments (on Cypress, Willow, and Sangerabout 2,650 LF)
- 86 sidewalks- new & repairs *Preliminary engineering study performed Nasland Engineering (Redevelopment funds)*
- Two streetscape locations (in/around SYB/Olive)
- <u>2011</u>: Encompasses thirty-four street segments (21 commercial and commercial corridors & 13 residential streets)—*None implemented* 75 locations:
  - 17 new streetlights
  - 11 new sidewalk segments (combined 7,475 LF)
  - 24 sidewalk repairs (includes certain locations over utility grates requiring antislip treatment)
  - 10 public amenities (including landscaping/green spaces)
  - 7 "other"
  - 6 street repaying segments (SYB- CdlP to Via SY; CdlP- Camiones Way to Willow; Beyer- E.Beyer to Smythe; Dairy Mart- Servando to CdlP)

#### 3. Discussion:

- A. Re street widening/sidewalks at 4570 Camino de la Plaza
  - understood that at least \$350,000 additional redevelopment funds set aside (minimum \$650,000 combined)

- all residual redevelopment funds due San Ysidro said to be resolved by San Diego "successor" entity by June
- B. Re sidewalk- new & repairs (total 110 locations, both 2009 & 2011 rounds):
- Re 2009 round 86 locations, reported that \$950,000 set aside from residual redevelopment funds, to be resolved by "successor" entity

#### 4. Conclusions/Next Steps:

- A. Melina Meza agreed to follow up before San Diego's "successor" agency status set asides both Camino de la Plaza street widening and 86 sidewalk repairs/new.
- B. In order to energize sidewalk component, subcommittee will identify twenty-five of the most egregious sidewalk in need of repair—repairs that should be made as a matter of public safety to alleviate dangerous conditions. Otto will work with Andres Ripa to prepare a Photo Gallery, to be conveyed to lead City Traffic Engineer (Samir Hajirri), and Council District 8 for action. Recommended is a strong letter of support from SYCPG.
