  - **a.** Crash reports.
  - **b.** 118 bike thefts, 19 from residential storage. Bike-bait program. \$1800 capital plus \$60 per month tracking. 55 arrests, 100% conviction rate.
- 8. Subcommittee for BMP Implementation Strategy

- **A.** KH: Several meetings with district 6 and 8 staff, with transportation engineering staff. CAP 6% by 2022 (conditioned on the buildout of the BMP). At 2010 we were at 2%
- **B.** KH: SIP we should take advantage of mayors's street resurfacing initiative. The city should start tracking the CIP percentages devoted to the alternative modes of transportation. District representatives are looking for a list of projects where bike improvement can be done.
- **C.** Q&A:
  - **a.** ML: CIP prioritization 800-14 policy. Mode share shift should be part of ranking projects.
  - **b.** JW: Councilmembers expect a list of projects from us.
  - **c.** ML: joint letter from the committee.
