3. **Meeting Minutes:**

**Further discussion on Presidio/Jackson St. one-way traffic study**

## **6. Information items:**

### Presidio Heritage Trust/Presidio Park Council

Paul Chace passed out the PHT Citadel newsletter. Subscriptions are available at no charge, and the newsletter is available in several languages.

Fred Grand inquired about whether the Presidio Park Council is still active. David Swarens informed that the City is considering the status of this group, and no decision has been made to date. Ann Dahlkamp will put this item on the agenda at a future meeting for further discussion.

### Founders' Day Activities

Fred Grand gave a recap on the Founders' Day event. Several community leaders and groups were represented and actively participated. Positive feedback was received from attendees.

### Utilities Undergrounding District UU852 Block 2F

City representatives were in attendance to give an overview of this project. Items of discussion included project boundaries, planning and design, environmental concerns, and habitat and historic resources.

Of particular concern was determining possible unidentified burial sites in El Campo Santo. Ground penetrating radar was used in this process. The question was brought up as to what would happen should a burial site or other significant historical artifacts be found during construction. Should such an event occur, the project would be put on hold for further investigation.

### Property at Harney & Congress

The proposed parking lot at Harney & Congress is in the permit process. This lot will include EVS parking spaces that will be placed adjacent to residential property. Other potential locations for EVS spaces are being explored in Old Town, including the large parking lot behind Immaculate Conception Church.

### State Park Update

Cindy Krimmel, CA State Parks, informed that a new Parks Superintendent has been appointed. The new superintendent will attend a future meeting for introductions.

### City Council Update

Tyler Renner distributed Chris Ward's newsletter. A report on homeless issues will be presented to the City Council next week. Two community outreach events are scheduled for the month. Details for each event are included in the newsletter
