#1) Request for help for Special Event at the AG Pool before the concerts in the park

## **WORKSHOP ITEMS**

#1) Proposed San Diego Municipal Code (SDMC) changes to include Pasatiempo Park (undeveloped) and Pasatiempo Park West Open Space to be included on the list having the dusk till dawn curfew, and prohibition of alcohol, glass containers, open fires, off roading, urination, defecation, abandoning property, overnight camping, smoking, hunting and firearms.

Council District 7 representative Anthony Hackett provided a power point presentation of the problems the neighbors are experiencing at Pasatiempo Park to include loitering, drug and alcohol use by both Patrick Henry High School students (during and after school hours) and by adults throughout the night time hours. Neighbors Keith Simmons and John Fernandez provided additional information and photographs of the problems the neighbors are experiencing.

The current signage is insufficient and the San Diego Police Department and the San Diego Unified School District Police have request additional and more appropriate signage to enable them in the enforcement of the rules. It is currently unsafe for neighborhood and visiting families and children to walk around the park or open space or to enjoy the view.
